Topic Original Report

M.O. By entering an unlocked back door to the victim's residence, taking the listed items without the owner's permission, and leaving with same.

On 9-29-08, I was detailed to 2210 Woodward regarding a house that had been possibly broken into and items that were missing. Upon arrival, I spoke with VIC/THOMAS MOLESKI and VIC/JEFFREY HUNTER, and learned the following.

MOLESKI and THOMAS are roommates. They both left for work around 0800 hours. THOMAS returned home at 1730 hours and began to cook dinner. MOLESKI returned home around 1800 hours. THOMAS went to turn the television on in the front room. THOMAS stated the television was unplugged and would not turn on. THOMAS then noticed his Playstation2 was missing and also a video game. MOLESKI'S I-Pod was also missing. THOMAS and MOLESKI then checked the rest of their residence and found other items missing. THOMAS called LPD.

MOLESKI advised me that when he left for work he did not lock his back door. The back door leads to the kitchen. The front door leads to the living room area. The television set was located in the living room. There was a laptop, GPS system, and other electronics that were in the living room, but they were not taken. There are stairs that lead to the upstairs of the residence. The stairs lead to an open hallway. There was a door that was opened but nothing was disturbed. Directly to the east there is a spare bedroom. There were several drawers opened but nothing was taken. MOLESKI advised me that he had wrapped Christmas presents under the bed. The presents were opened but nothing was taken. The room directly south of that is a computer room. MOLESKI and THOMAS advised nothing was missing in that room. Their bedroom is directly south of the computer room. THOMAS advised me that his night stand drawer was opened and his digital camera and I-Pod charger were missing. THOMAS and MOLESKI advised those were the only items missing. INV.PICKENS responded but found nothing of value.

I spoke with the neighbor at 2206 Woodward and he stated he was at work all day and didn't see anything suspicious. I spoke to the other neighbor, WIT/SUZANNE SIMONS, at 2212 Woodward, and learned the following. SIMONS stated at 1330-1400 hours, her dog was barking. SIMONS looked out the window and stated she saw two juveniles wearing red t-shirts and black jeans walking north on Woodward from Delaware. SIMONS believed these two juveniles were females. SIMONS stated she saw the juveniles cut across the lawn of 2210 Woodward. SIMONS stated she thought they were just cutting through the yards and did not call LPD. SIMONS stated she would recognize these females if she saw them again.

Disp. Lewandowski entered the Playstation2, I-Pod, and Camera as stolen in LEADS.

THOMAS and MOLESKI desire prosecution.
