Topic Original Report

M.O. By being in possession of the listed two baggies of cocaine.

On 9-29-08, at 2353 hours, I observed that the listed vehicle, which was travelling WB on Northwood, did not stop before the stop sign at the Granger intersection. I stopped the vehicle on Detroit at Cordova and advised the driver, OWN/ of the reason for the stop. Sgt. L. WILKINS arrived on the scene to assist. The front seat passenger, who was not wearing a seat belt, was identified as ARA/CORY MALEC. MALEC showed to have a warrant out of GOV/MENTOR PD. The rear passenger, SUB/DAVID JARVEY, showed to have a warrant out of GOV/ROCKY RIVER PD. Dispatch confirmed both of the warrants.

I arrested MALEC and during a search of his person, I found a small baggie of cocaine in his front left pocket. P.O.RUSNAK arrested JARVEY and was placed in his patrol car. P.O.RUSNAK transported JARVEY to the Hilroc where he was released to Rocky River Unit 13.

In speaking with she was on her way to Lakewood Hospital to pick up a friend of MALEC's. She explained that she was merely giving him a ride and denied knowing anything about MALEC having cocaine. MALEC later admitted that the cocaine belonged to him and that had nothing to do with it. A message was left for 's mother to contact this officer about the circumstances surrounding the stop. was given a warning for the traffic violation and released enabling her to pick up their friend.

I transported MALEC to LPD where he was booked in by C.O.MCCARTHY for (F)Drug Abuse, Seat Belt and Warrant Other PD. During the booking of MALEC, he was advised that a strip search was going to be conducted. He stated that he might have more drugs in his shoe. MALEC removed another small baggie of cocaine from his right sock. Nothing was found during the strip search. MALEC does not have a CCH.

The baggie of cocaine that was found in MALEC's pocket weighed .7 grams and the baggie that was in his sock weighed .38 grams. They both field tested positive for cocaine using the Nark Kit. I tagged the cocaine and placed it down the property chute of the LPD Property Room.
