Topic Original Report

MO/ By being in possession of a controlled substance, To wit: the listed crack cocaine in an amount greater than or equal to 1 gram but less than 5 grams.

MO/ By being in possession of an item commonly used to inhale/smoke crack cocaine, To wit: the 2 listed crack pipes with burnt residue.

On 09-30-08, while on patrol in the area of Madison and W.117th, I observed the listed vehicle. In checking the registration, OH Lic# DRD 8035, it showed that it expired on 09-07-08. The registration also showed that the listed owner (ARA) RINI; WILLIAM, was under suspension with limited privileges. The vehicle turned into the area, commonly referred to as "Birdtown," but I was unable to locate the vehicle. A few minutes later, I observed the vehicle turn from Dowd onto eastbound Madison.

The vehicle was stopped as it pulled into the drive at the Shamrock Tavern, located at 11922 Madison. The driver of the vehicle was identified as RINI. In speaking with RINI, he was extremely nervous and sweating profusely. RINI stated that he had driven from his business in Parma to Lakewood. RINI stated that he has a worker named "WAYNE" who lives on DOWD and he was picking him up for work.

RINI stated that when he arrived at "WAYNE's " residence, he was not home. RINI stated that "WAYNE" is a regular at the SHAMROCK so he was going to check the bar. RINI advised that he is under suspension from an OVI in April of this past year. RINI stated he has work privileges but did not have the paperwork with him at the time of the stop. INV. PICKENS then arrived on the stop to assist.

INV. PICKENS remained at the passenger side of the vehicle as I returned to my cruiser. INV. PICKENS then advised that he observed RINI attempting to conceal something in a cigarette pack. When I walked back up to the vehicle, RINI was attempting to place something down the front of his shorts. When RINI observed this officer back at the vehicle, he put the item back into his right front pocket.

RINI was removed from his vehicle and advised that he was going to be patted down due to his furtive movements in the vehicle. At that time, RINI stated "I got dope." INV. PICKENS then located the listed clear plastic baggie of crack cocaine in RINI's right front pocket. RINI was then handcuffed and secured in P.O. GREEAR's patrol car #203. In a search of RINI's vehicle incident to arrest, I located a homemade tin foil pipe next to the driver's seat. The pipe contained what appeared to be burnt residue.

I then advised RINI of his rights which he acknowledged understanding. RINI admitted to having a crack cocaine problem and coming to Lakewood to purchase crack cocaine. RINI stated that he met with a male on DOWD to purchase his crack cocaine. RINI then advised that he had another crack pipe in his right front pocket. A silver metal pipe with burnt residue was located in this pocket.

In checking RINI through the computer, he was found to be under a Court Suspension/OVI from 04-07-08 to 04-07-09. At the time of the stop, RINI was not driving due to any type of emergency. A tow was then ordered for the vehicle which is to be held pending court order release. KUFNER TOWING responded for the vehicle.

I then transported RINI to LPD where he was booked by C.O. McCARTHY. RINI was booked for Possession Crack Cocaine, Possession Paraphernalia, DUS, Expired plates and Seatbelt. Due to the drug charge, a strip search was completed. No further contraband was located on RINI. RINI was issued citation #D163765 for the traffic charge. No citation was issued for the paraphernalia. RINI has a CCH with [REDACTED] and [REDACTED]. RINI has prior arrest for DV and Violation of State Drug Law (Sept. 2000)

The narcotics weighed 2.75g and field-tested positive crack-cocaine. The narcotics and paraphernalia were tagged and placed down the drug chute located in LPD's secured property room.
