Topic Original Report

M/O: By stabbing the victim with the listed kitchen knife causing serious physical harm.

Sgt. L. Wilkins,

On 09/30/08, at approximately 0122 Hrs., officers and LFD paramedics were detailed Code 3 to 1342 Beach Parkway #4 on a report from ARA/CHRISTINA MOORE that she had stabbed her boyfriend in the shoulder. Dispatch advised that CHRISTINA stated that her boyfriend, VIC/NATHANIEL GUCIK, was barely conscious. It should be noted that it was later determined that CHRISTINA and GUCIK were engaged to be married.

P.O. RODA and INV. PICKENS were already on scene when I arrived. Inside the front door of the apartment is the living room. There was a small child sleeping on the living room couch who was later identified as OIV/. The dining room is off of the living room. The kitchen is the only room off of the north end of the dining room. Off of the south end of the dining room is a bedroom to the east, a bedroom to the west, and a bathroom located in the middle. OIV/ was found to be sleeping in the eastern bedroom.

Both CHRISTINA and GUCIK were in the kitchen. GUCIK was found on his back laying on the floor. From where this officer was standing, I could only see the lower half of GUCIK'S body. There was a very large amount of blood on the kitchen floor and on GUCIK. CHRISTINA was standing over him attempting to help stop the bleeding. INV. PICKENS advised me that GUCIK had a stab wound to his right shoulder area, which was bleeding profusely. INV. PICKENS stated that the knife that had been used to injure GUCIK had been located and secured. INV. PICKENS later photographed the kitchen.

I heard CHRISTINA saying that she and GUCIK had been arguing and she stabbed him. LFD paramedics arrived moments later and CHRISTINA was asked to move out of the kitchen so that GUCIK could be treated.

I spoke to CHRISTINA in the dining room. She stated that she had gone out to a movie with some co-workers, and was supposed to be home by 2300 Hrs on 09/29/08. She stated that she did not arrive home until approximately 0030 Hrs, and this angered GUCIK. She stated that they started arguing but then moved into the kitchen so as not to disturb CHRISTINA stated that they continued to argue and at one point she told GUCIK, "stop yelling at me or I will stab you!!" She stated that GUCIK continued to yell at her, so she retrieved a knife from a drawer in the kitchen and stabbed GUCIK. Once she realized how badly he was injured, she called 911.

CHRISTINA stated that the two often argue, but it is has never been "physical." I asked her if GUCIK hit her or had possibly done anything else to her and she stated that the argument was strictly verbal, and "he would never put his hands on me." CHRISTINA stated that when they argue, it is normal for her to threaten GUCIK. She stated that she usually threatens to "bop" him, but has never threatened to do something as serious as she had done tonight.

CHRISTINA showed no emotion while I was speaking with her. CHRISTINA stated that she does not take any medications and does not suffer from any mental illness.

At this point, CHRISTINA was handcuffed, searched and seated on a couch in the dining room.

Paramedics advised that GUCIK likely had a severed artery, as they could not control the bleeding. They requested additional help so that they could get GUCIK to the ER. Several other LFD firefighter/paramedics responded and assisted in caring for GUCIK. He was then transported to Lakewood ER. The shirt GUCIK had been wearing was cut off by the paramedics. INV. PICKENS took the shirt as evidence. He later tagged the shirt and secured it in the LPD property room.

Dispatch contacted CHRISTINA'S mother, OIV/MIRRIAME MOORE, to take custody of and P.O. ROMANELLO then responded to MIRRIAME'S residence and transported her to the apartment. After it was determined that MIRRIAME had everything she needed to care for the children, P.O. RODA transported CHRISTINA to LPD Jail. He DISP. LEWANDOWSKI and C.O. MCCARTHY booked her in for Felonious Assault. Her clothing was taken as evidence and it should be noted that most of it had blood on it. P.O. RODA secured these items in the LPD property room as evidence.

SGT. KAUCHECK, INV. PICKENS, and I responded to Lakewood ER in an attempt to speak with GUCIK. We were unable to speak with GUCIK due to the fact that he was bleeding so severely that the staff was attempting to get him stabilized so that he could be taken directly into surgery. DR. WELLBACKER was treating GUCIK. I was unable to speak to him about the injury as he was extremely busy treating GUCIK, and went up to the OR with GUCIK when he was transferred. I was advised that GUCIK likely had nerve damage as he complained about not being able to feel his right arm.

I also spoke with LFD paramedics and learned that the stab wound was located on the top of GUCIK'S right shoulder. It was located approximately mid way between his neck and the outside of his arm. It was approximately 1.5 inches wide and several inches deep.

A copy of the 911 call that CHRISTINA made to LPD was obtained as evidence. In listening to same, CHRISTINA could be heard saying that she had stabbed GUCIK. The CD was tagged and secured in locker #18 of the LPD property room.

I contacted the Domestic Violence Hotline and gave JOANNE the pertinent information. I contacted Children Who Witness Violence and gave Therese POTOCKI the pertinent information. I also contacted 696-KIDS and gave MRS. TYSON all of the pertinent information. TYSON provided referral #491791.

CHRISTINA does not have a CCH.
