<p>Detailed on 10-1-08 at about 1140 Hrs. to 1500 Cohasset Ave. on the report of a home entered and stained glass windows stolen. On Officers arrival we spoke to COM/VIRGINIA VIGRASS who advised the following.</p> <p>VIGRASS stated that this home was foreclosed on sometime in 4-08. VIGRASS stated she believed the owner of the property was CPY/WELLS FARGO HOME MORTGAGE. VIGRASS stated that she just notice two stained glass windows missing from the property. VIGRASS stated that this could have occurred anytime between 4-08 and today. VIGRASS decided to report the matter at this time.</p> <p>In checking the home, it appears someone has been either doing some work on it or is otherwise living at the property. Numerous personal effects were located inside and PVC has recently replaced the copper piping in the basement.</p> <p>The point of entry was determined to be the north side door. This door had the lock enabled but can easily be forced open as the lock itself does not sink all the way into the frame. One window was missing from a north wall in the living room on the east side first floor of the home. The second window was missing from a south side wall also in this room. Inv. Malloy processed the scene. See his photo sheet for details.</p> <p>VIGRASS stated she does see teenagers on or around the property at times but has no idea who they are. VIGRASS was advised to call LPD back if she sees anyone on the property who should not be there. In later checking the Cuyahoga County Auditors home page online, the current owner could not be located. Also, the property did not show up as a foreclosed property available for sale on WELLS FARGO's website. As of this time it is not known if someone may have entered the home and stole teh windows or if a new owner or their designee may be working on/in the home.</p>
