Topic Original Report

MO-By entering the victim's home, taking two bra and panty sets and leave area.

Detailed on 10-1-08 at about 1421 Hrs. to 2062 Wyandotte Ave. on the report of a home entered. In speaking with the complainant, VIC/MARY BERRIOS, I was advised of the following.

MARY stated that she left the home at around 1100 Hrs. to do some errands. Between 1200 and 1215 Hrs., MARY stated she received a phone call from her home on her cell phone. MARY stated the caller did not say anything. MARY thought there may have been a bad connection or her cell phone dropped the call. MARY further advised she believed that it may have been her daughter, OIV// trying to call her however, she knew it was too early for her to be home from school. MARY then returned home and found some papers scattered about in the dining room. MARY spoke with her upstairs neighbor, OIV/CHRISTINA MACDONALD, however she did not see or hear anything unusual. Eventually, MARY called LPD for a report.

In further checking the home, the point of entry into the home was found to be 's bedroom on the southeast side of the home. MARY stated shares this room with her sister. The window for this room had been cracked open slightly but was now found to be closed. The window blinds were found to be slightly disturbed and the curtain moved to the side.

The suspect(s) also targeted MARY's lingerie drawer, taking the indexed bra and panty sets. This drawer is the top one located in a dresser in the southwest corner bedroom that MARY shares with her baby. The dresser opens to the east and is just at the entrance to her room. The suspect(s) also targeted a file cabinet on the north wall of the dining room in the center of the home. The only landline phone in the home is located just west of this cabinet. The suspect(s) likely called MARY from this phone and then left through the back west side door.

Inv. Malloy was requested to the scene and processed the area with negative results. In further speaking with MARY, she advised that she does not have any suspects in this matter. MARY stated that her ex-husband, whom she has a decent relationship with, was at work during the listed times. MARY does not suspect any ex-boyfriend(s).

MARY added that she just got a job at the Target on W. 117th St. near I-90 but has not started yet. MARY does work on occasion with a band as a singer. The band maintains a website at www. com. MARY stated that she has been approached by individuals at different events the group has played for information on booking them. MARY stated she has given out her cell phone number in the past to these individuals.

MARY was advised that whoever broke into her home would have to have her cell phone number to call her. MARY stated aside from the previously mentioned parties she has given out her number to at different events, only a select number of people have her cell phone number. MARY was advised that due to the nature of the items taken it would seem that whoever did this has a personal interest in her. MARY stated that to her knowledge, she does not have anyone "stalking" her and was still unable to provide a suspect.

In further speaking to MACDONALD and OIV/RICHARD SALAH, they advised the following. A few

weeks ago, MACDONALD and SALAH were sleeping at their home. MACDONALD stated that an unidentified male had somehow climbed up onto their second floor front porch and was trying to get inside. This was around 0400 Hrs. SALAH must have "spooked" the male when he got up quickly to get a baseball bat and stop the male. Both MACDONALD and SALAH stated the male was able to get back downstairs and run from the area before SALAH could locate him. Neither MACDONALD or SALAH called LPD at the time to report the incident. Both parties were advised to do so if such an incident were to occur again.

In speaking to \_\_\_\_\_, she stated that at about 0300 hrs today she heard a banging at her bedroom window that she thought was a result of the weather but it could have been someone knocking on her bedroom window. \_\_\_\_\_ stated she did not tell MARY about it because she assumed it was just the wind.

MARY was advised on the report and given the report number for her records. MARY was further advised to call back should anything else be found missing.
