Topic Original Report

- M.O.-By jumping out of a vehicle after being stopped by the Police and fleeing the scene on foot.
- M.O.-By having open bottle of Hennessy Cognac in back seat of auto.
- M.O.-By having marijuana "blunt" on floor in back seat.

On 10-1-08, at approx. 2152 hours, I was on routine patrol in the area of W.117 and Detroit, heading westbound on Detroit with the listed vehicle in front of me. I ran the listing as a random license plate check and observed that the plate listed to a Jeep, but it was on a Plymouth Breeze. The vehicle turned northbound onto Hird and I activated my lights to stop the auto. The auto continued Northbound for several seconds and finally stopped. As I opened my door to the cruiser, the vehicle started to leave the scene north on Hird. I followed the auto and as we got to the railroad tracks the vehicle stopped and the driver door flew open, with the driver fleeing on foot. Inv. Motylewski was behind me and began to pursue the male on foot as he fled eastbound through the Sapelle's lot. I had to stay with the vehicle due to the fact that there were four other parties inside. Inv. Ginley and Sgt. Donahue arrived as back-up.

The four remaining occupants were removed from the auto in a felony stop procedure due to the fact that we believed the auto may be stolen. ARA'S-JONATHAN HOGUE, PERRY and SCOTT were in the back seat and ARJ- was in front seat. Once the occupants were secured, I responded to the area of W.116 and the tracks to search for the driver, later identified as SUS-JENKINS. During our search we learned that the male was spotted several minutes prior in the area of W.114 running eastbound through the yards from there. The area was checked for JENKINS with negative results.

I responded back to the auto and spoke with the occupants who advised the following: JENKINS is the boyfriend of and friends with the other three passengers in the auto. They were all headed to North Lane to visit a friend prior to being stopped. When I pulled behind them, JENKINS became agitated and scared saying that he had to run because he had warrants. At first no one could tell us JENKINS name. They only knew him by his first name of Devin.

While on scene, HOGUE'S mother showed up and the situation was explained to her. She advised that she also only knew the male as Devin, although he was staying at their house. It did not appear that anyone wanted to release JENKINS' identity.

Due to the fact that the plates did not match the auto, we had Kufner's respond. An inventory of the auto found an open bottle of Cognac in the back seat, which JONATHAN admitted was his. Also found on the floor of the driver's side back seat was the listed marijuana cigarette. No one claimed ownership of the blunt, so all were cited for Drug Abuse. Due to being a juvenile, no citation was issued to her.

The vehicle was towed to Kufner's to be held for owner, licensed driver and proper registration. While waiting on the tow, OIV-GWENDOLYN HOGUE, advised that the auto was hers. She had no paperwork other than an insurance sheet showing any type of ownership. I explained to her several times that the plates listed to OWN-JONES and the vehicle could not be released until the plates got straightened out. GWENDOLYN could not understand and became uncooperative. She would not listen to my explanations and was advised that she needed to straighten this out with the BMV.

was released to GWENDOLYN at the scene.

JENKINS' information was found in the computer by dispatch. When running JENKINS, he was found to have several felony warrants with the GOV-CCSO for Probation Violation and Trafficking in drugs. JENKINS' information matched what gave me at the scene. JENKINS' was also
