Topic Original Report

MO- By pushing an air conditioner unit through the bedroom window to gain entry into the downstairs unit of the double, enter home through window, and steal listed items.

On 10-02-2008, at 1147 hrs, I was detailed to 2116 Waterbury Rd. (dn) , on report of items stolen from the home. On arrival, I spoke with (VIC) DAVID M. ANTHONY who was reporting items stolen . ANTHONY advised that he had been in jail last evening . He spent the night of 10-01/02 in Elyria Jail as he had a warrant for traffic from North Olmsted PD, who did not have room for him.

ANTHONY returned to his downstairs unit at 1130 hrs this date and discovered the indexed electronics missing from the home. The front door was open when he returned. ANTHONY has several other room mates, one of which was home at this time. I spoke with (OIV) DAVID E. MILLER who advised that he left the house early last evening and did not return until after ANTHONY got home.

The last person to leave was (VIC) DAVID D. SOWASH , who was currently at work. He had left the house at 1930 hrs on 10-01-2008 and stayed with a girlfriend. ANTHONY showed this officer a back bedroom where the suspect(s) were believed to have entered the home. The bedroom was to the west side of the home and an air conditioner unit, which had been in the northern window, was now on the bed. It appears that the suspect(s) pushed the A/C unit onto the bed, then climbed into the window.

The items missing were a 27 inch flat screen TV , which was located in the living room in the east side of the home. A lap top , which had been on the couch in the same living room. This item belonged to SOWASH. also taken was a Playstation 3 box, which was next to the TV that had been taken.

Photo's were taken both inside and out. A shoe print was noticed in the mud, near the window which had been entered. The print was approx 20 feet east of the window. Photo's were taken of the shoe print. The A/C unit was processed with negative results.

ANTHONY suspects a male named (SUS) MICAH RILEY, who used to live with Anthony . Both had gotten into a fight approx two months ago and RILEY moved out. ANTHONY added that RILEY has been arrested in the past for thefts , and has no job. He believes RILEY is currently on probation.
