<p>MO: By entering victims unlocked home and taking victims property without permission.</p> <p>On 10/2/08, at 1917 Hrs., I was detailed to 2121 Arthur on a report of a home being burglarized. On arrival I spoke with victims VIC/MICHAEL MCCANN and VIC/JOYCE HUMEL and learned the following. MCCANN stated he left the hose at around 1545 Hrs to go golfing. He stated he left the front door unlocked because he knew HUMEL would be arriving home shortly. HUMEL stated she arrived home at around 1745 Hrs. and noticed that her laptop computer was missing from the dining room. She said she waited for MCCANN to arrive home and they checked the rest of the home. They discovered that a laptop computer was also missing from the upstairs office. MCCANN stated he then called LPD. MCCANN also advised that a digital camera and a Mp3 player were also taken from the dining room.</p> <p>The dining room is on the northwest side of the home and the laptop was on a small table in front of the window. The digital camera and the Mp3 player were also on this table. The table was covered with a table cloth. MCCANN stated the blinds on the window were left open, the laptop could have easily been seen from the front porch. The office is located on the second floor in the southeast corner of the home. The laptop taken from the office was on a desk. The power cord and the wire used to connect to the Internet were also missing. No other rooms in the home appeared to be disturbed.</p> <p>MCCANN advised that his neighbor OIV/VICTORIA POLICARD at 2125 Arthur had a crew of men removing trees from her yard. He stated that when he left to go golfing the crew appeared to be cleaning up for the day. MCCANN stated he believed the men observed him put his golf clubs in his car and leave.</p> <p>I spoke with POLICARD and she stated she was at work at the time. She stated that CPY/OHIO TREE .COM TREE SERVICE is the company she hired to remove the trees. MCCANN stated he spoke with his other neighbors in the area. He stated the neighbors he spoke with were not at home during the time frame.</p> <p>MCCANN stated he didn't have any suspect(s) but does desire prosecution if one was located. He was advised of the solvability factor. INV. DEUCHER processed the seen but found nothing of value. The Sony laptop computer was entered into the computer by dispatcher Malloy. MCCANN had very limited information on the other stolen electronics.</p>
