Topic Original Report

M.O. By pushing victim to ground, taking her purse without her permission, and leaving with same.

On 10-3-08, Officers were detailed to the area of 2053 Elbur regarding a female who was robbed for her purse. Dispatch advised Officers there were three black males, who left north on Elbur, who were the suspects. Officers responded to the area to check for the males but were unsuccessful locating them. Myself and PO PERHACS responded to 2053 Elbur to speak with the victim.

We spoke with VIC/HILARY ROMAN and her boyfriend, OIV/TERRY LYNCH, and learned the following. ROMAN stated she and LYNCH were walking south on Elbur from Madison. They were walking on the east side of the street. ROMAN stated she saw three black males walking northbound. ROMAN stated that LYNCH was approximately 4 steps in front of her. They were in front of 2041 Elbur when the three males passed them. The first two males walked by and said "Hey". The last male wearing a camouflage jacket grabbed ROMAN and pushed her down to the ground. ROMAN stated she looked up and saw the male in the camouflage run north toward Madison. The other two males also ran north, then ran eastbound into a backyard. ROMAN stated she did not know what just happened, so she and LYNCH walked back to her residence at 2053 Elbur.

While at the house, one of her roommates made a comment regarding her getting mugged. ROMAN and LYNCH didn't think anything of the comment. ROMAN stated a few minutes later she went to find her purse, but realized it was missing. Once they realized this, ROMAN called LPD.

While Officers were speaking with ROMAN, LYNCH came walking back from Madison Ave. LYNCH located her purse along with receipts and other miscellaneous papers. LYNCH stated he located the purse at the southeast corner of Elbur and Madison. ROMAN stated there were several items that were missing. Officers checked the area where the purse was located at. There was no other evidence found, except receipts that belonged to ROMAN.

ROMAN and LYNCH stated there were three black males approximately 18-20 years of age. The best description they could give were two of the males were wearing black hooded sweatshirts and the other male who pushed ROMAN down to the ground, was wearing a camouflage jacket. ROMAN stated it was dark out and it happened so fast, she could not get a good description.

While on scene, SGT.KAUCHECK called out with three parties, OIV/JAYMES JONES, OIV/ and OIV/ANTONIO PRITCHETT, who matched the description of the suspects, in front of St. Cyril's. I transported ROMAN and LYNCH to their location for a positive id. The parties SGT.KAUCHECK stopped were not the suspects. I transported ROMAN and LYNCH back to their residence.

ROMAN stated the listed items were stolen. ROMAN stated the only information she had regarding her missing credit cards was her debit card. ROMAN provided me with the numbers for her debit card. ROMAN was advised to call back if she could get the other numbers to her credit cards and the serial number to her cell phone. ROMAN was advised to cancel her credit cards.

ROMAN stated she desires prosecution. ROMAN was advised of the low solvability regarding the incident.
