

Topic Original Report

Sgt. WYNALEK Sir;

Dispatched to the area of Ridgewood/Franklin on the report of a female being robbed. Dispatch advised that the female was difficult to understand and not making much sense. On arrival, COM/ W advised the following:

She had walked to the Shell station at Franklin/W.117 to buy lottery tickets. While there, a male asked her if she wanted a ride home. W accepted the ride, and got into an auto which she could only describe as an older, white, two door. W said that she had never seen the male prior to today's date. She provided the listed description, and added that the male had a tattoo on the right side of his neck. W said the tattoo resembled a pair of lips, as if the male had been kissed by a female wearing too much lipstick.

W said they left the Shell station and she asked the male to take her home. She claimed that the male did so, but reached into her pockets and removed \$52 in cash. He then told her to get out of the car at the corner of Ridgewood/Franklin, which she did. The male then left in an unknown direction.

W story was vague and did not seem credible. W was insistent that she had been robbed, and that she wanted to prosecute the male. I advised W regarding a false police report, and she then said "he raped me too".

W was asked why she did not mention that earlier, either to me or dispatch, and she could not say. W now claimed that she got into the car, but could not remember which direction they headed when they left the lot. W said the male took her into a parking lot of an apartment building and raped her, but could not give any further detail.

W was told that she would have to provide further information, and after much questioning, W claimed that the apartment complex was tan and that there were a series of buildings. W said that when the male parked in the lot, he told her "I'm going to get some sex out of this". W said she did not want to get hurt, so she pulled her pants down and said "Just get it over with". W claims that the male crawled across the center console and had sex with her in the front seat. W did not know if he had a condom on or if he ejaculated.

W said after the male was done, he began to drive again. The male allegedly reached into her front jean pocket and pulled the money out. W claims the male barely slowed the auto down, and pushed her out of the passenger door in the area of Coutan/Franklin. The male then allegedly left S/B on Coutant, and W walked home. W gave a possible plate of 356 XUH, which lists back to a black auto out of Cincinnati. W was sure the auto was white.

W could not say why she would not call LPD right away on her cell phone rather than walking home and then using her cell phone, and again she could not provide an answer. W was again informed of making a false police report. I asked W if she would be willing to go to the Hospital for a rape kit, and she said that she would not, and that she was just going to take a bath. I told W that a rape kit could provide necessary evidence, and she again declined.

W would not provide a written statement. She said that she just wanted us to know what happened, and did not want to prosecute. W then said she did not want us to do anything else, and went into her residence. W had no visible injuries, nor did she claim any. Her clothes were clean and orderly.

Officers responded to the Shell station and spoke with OIV/AMBREEN ZAHOOR. ZAHOOR remembered W stopping by this morning, as she is a regular customer. ZAHOOR said that the car had been in the lot for a few minutes prior to W arriving, and was sitting along the North wall of the lot. ZAHOOR said the driver did not purchase anything. As soon as W was done buying her lottery tickets, she walked over to the car and got inside.

ZAHOOR said that it looked as if the auto had been waiting to pick up W. She said that W was not forced in the car. ZAHOOR said that the auto left N/B on W.117. She could provide no further details on the car or the driver. There are cameras in the lot, but it is unclear if they cover the area where the car had been parked. ZAHOOR said the owner of the station would be able to assist in reviewing the footage if necessary.
