Topic Original Report

M.O.: By entering an occupied apartment without the tenant's consent.

SGT Spaetzel, Sir,

Detailed to 11855 Edgewater #307 on 10/6/2008 at 0947hrs. Dispatch advised that a tall, thin, possibly Hispanic male wearing a hoodie and blue jeans was found without consent in an occupied apartment. Dispatch advised that the SUS was last seen leaving the apartment in an unknown direction. SGT FAVRE and Officers THIBODEAUX, ROBINSON, and BENO checked the area. I arrived on scene and spoke with VIC/JESSICA GENSEL.

GENSEL advised that she had began taking a shower at approximately 0930hrs on the day of this report. GENSEL stated that her boyfriend, OIV/ROGER EVANS, had left for work earlier in the morning and had locked the apartment door after exiting. GENSEL stated that no one else should have access to the apartment and that no one else has a key. After showering for approximately 15 minutes, GENSEL heard the bathroom door begin to open. A hygiene bag was in front of the door, partially obstructing the door's ability to open. GENSEL stated that she looked out of the shower to see the door beginning to open and then abruptly stop. GENSEL exited the shower, covered in a towel, and exited the bathroom in an attempt to see who was in the apartment. GENSEL observed the SUS described above leaving the apartment through the front door. GENSEL only observed the SUS from the back. GENSEL stated that she did see the SUS'S hand as he closed the front door behind him. GENSEL stated that his skin was medium-brown and she felt that he looked to be Hispanic. GENSEL locked the door and notified LPD.

Nothing was missing or disturbed within the apartment. No signs of forced entry are apparent. There is only one entry/exit door to the apartment. The door has a dead bolt and a separate lock on the door knob. INV KULCZYCKI was detailed and processed the door for latents with positive results.

GENSEL stated that she heard the front apartment door attempting to be opened in the early A.M. hours on the day of this report. GENSEL is unsure of the exact time. GENSEL alerted EVANS to the noise, but EVANS did not hear it. GENSEL heard the door knob to the front apartment door being "turned back-and-forth." GENSEL feels that the two incidents are related.

GENSEL spoke with EVANS while I was at her apartment. EVANS stated that he did not return to the apartment while GENSEL was in the shower, nor did he give anyone permission to enter the apartment on the day of this report. GENSEL does not believe that the building has an on-site maintenance staff that could be responsible. Neither GENSEL nor EVANS knows who may be responsible.

It should be noted that GENSEL was arrested on 3/29/2008 for Trafficking in Drugs, Drug Abuse, and Possessing Criminal Tools. GENSEL is on probation. GENSEL was asked if this incident could be related to her criminal past. GENSEL stated that she has been rehabilitated and no longer associates with the same people. GENSEL advised that none of her "old friends" or associates know where she currently resides, nor would they have cause to visit if they did.
