Topic Original Report

MO: By knowingly being in possession of a silver drug grinder, which contained residue of a green vegetable matter, consistent with that of marijuana.

On 10/06/07, at 0007 Hrs., I observed the listed Ford Taurus south on W.117th St. from Detroit Ave. I pulled behind the vehicle at Franklin Ave., and as we proceeded south, I did a random registration check. The temporary tag that was on the vehicle listed back to a 2000 Kia station wagon, clearly not a match to the 4 door sedan that it was on. I made a traffic stop on W.117th at Berea Rd. When I approached the vehicle, I noticed that the areas on the temporary tag where the vehicle year and vehicle make are located, had white-out on them, with 94 and Ford, written over it.

When I asked the driver for her driver's license and proof of insurance, she stated that she did not have either document with her. She identified herself as (ARA)CHARLEEN ROSADO and stated that she was the owner of the vehicle. I advised her of the reason for the stop, the fictitious plates. ROSADO stated that she was aware that the plates did not belong to the car. She said that the temporary tag belongs a friend's grandmother, (OWN)BLANCA AGOSTO. ROSADO stated that the temporary tag was put onto the vehicle because her license plates were expired and she needed to pick up her children from the babysitter's house. She was not driving due to an emergency.

When I ran ROSADO's information, I found that she had a suspended driver's license. She is currently under three open suspensions. The first is a Failure to File an Accident Report Suspension from 07/25/08 to Indefinite. The second is a Security Suspension from 07/25/08 to 03/07/10. And the third is a Non Compliance Suspension from the BMV, from 07/25/08 to 10/23/08, with an FRA attached from 07/25/08 to 07/25/11, fee required. When I advised ROSADO of the suspensions, she stated she was aware of them, and this was the reason the correct plates were not able to be renewed.

ROSADO was issued citation #D164222 for DUS (335.07) and Fictitious Plates (335.11). She was advised of the mandatory court date, time and the need to show proof of insurance. Incident to arrest and prior to tow, INV ALLEN did a search of the vehicle and located the listed drug grinder in ROSADO's purse. She admitted to owning the grinder, and advised that there was nothing else illegal in the vehicle. Nothing else was found in her vehicle, or on her person. ROSADO was then issued citation #M41571 for Drug Paraphernalia (513.04), and advised that the Paraphernalia charge would be addressed on the same day as her traffic court date.

The temporary tag was removed from the vehicle. The vehicle was towed to Kufner Towing and held for owner/licensed driver/proper registration/court auth. The license plate was confiscated, tagged, and placed in locker #11 of the property room. The drug grinder was confiscated, tagged and placed in the drug chute in the property room.
