N A R R A T I V E 1	Topic	Original Report			
<p>MO: By being the manager of the listed bar, and allowing their DJ to play music to a level that was disturbing to the neighborhood.</p> <p>On 10/09/08, at 2334 Hrs., PTL ORTIZ and I were detailed to the area behind 1366 Kenilworth on the report of loud music. On arrival, PTL ORTIZ and I parked our patrol cars in front of 1356 Phelps Ave. As we exited our patrol cars, we could hear music being played in the area. We began to walk around in an attempt to find out where the music was coming from. After several unsuccessful minutes, we decided to drive around the area. We checked Park Row, Owego, Maile, and Sloane, but were unable to locate the source of the music. The music was so loud, the lyrics of the songs being played could be understood in the area of Detroit and Phelps. But due to the echo effect off of the buildings, it was hard to determine where the music was coming from. While officers were looking for the source, several other people in the area approached officers regarding the disturbance. We continued to check the area both in our patrol cars and on foot. After 30 minutes, I decided to check further west. As I drove down Hafermalz, I found that the noise disturbance was coming from the patio of (CPY)Around the Corner Bar. I advised PTL ORTIZ who responded to my location.</p> <p>We went to the back patio of the bar where we spoke to (ARA)RYAN KRIVOSH. He stated that he realized that the music was probably too loud and told the DJ to turn it down. Immediately after he advised the DJ, officers arrived on scene. Officers advised KRIVOSH that the complaint was made 30 minutes prior to our arrival, and that we had been trying to find the source since that time. The DJ turned the music down after officers arrived.</p> <p>KRIVOSH, who was the manager on duty at the time, was issued citation #M41572 for Noise Disturbance (515.03 LCO) and was advised.</p>
