Topic Original Report

MO: By breaking the victim's listed front window, by unknown means, and entering the residence with the intent to steal prescription drugs.

Sgt. Wilkins, Ma'am,

On October 9, 2008, at 0006 hours, PTL. GREER, SGT. L. WILKINS, PTL. ORTIZ, PTL. CANTLIN and this officer were detailed to 2125 Halstead for a Burglary in progress. The COM/COLIN S. MAXWELL stated that he just observed a white male in a T-shirt and boxer shorts break the front window of his next door neighbor's house and climb through it to gain access to the residence.

Upon arrival, we observed a white male with boxers and no shirt standing in the driveway. He was identified as OIV/JOHN J. SHORTT. SHORTT stated that he was upstairs sleeping, was awakened by a crashing noise, and came downstairs to see what the noise was. SHORTT further stated that his landlord lives downstairs and was currently at a bar so no one should be inside of the house.

SHORTT then stated that somebody may still be inside of the residence. SHORTT told PTL. ROMANELLO that his girlfriend's son, ARA/AARON R. JENKINS, was at their residence, 2125 Halstead Up, earlier this afternoon. JENKINS was acting unusual and was told to leave.

Later that evening, their landlord, VIC/JOHN DANDREA, spoke to SHORTT and stated that JENKINS was back and told him that he did not have a place to stay. JENKINS was living at a half-way house, but checked himself out and came to see his mother. DANDREA asked SHORTT if JENKINS could stay the night with them. SHORTT agreed and told JENKINS he could sleep on the couch. SHORTT saw JENKINS on the couch, at around 2230 hours, and then SHORTT fell asleep. When SHORTT awoke to the crashing noise, he noticed that JENKINS was not in the residence.

The front, northwest window was shattered and off of its track. The doors were still secured. We gained entry into the residence through the broken window. We observed a trail of blood from the window, through the living room and into the kitchen. There were three empty prescription pill bottles tipped over with wet blood on the bottles. The three pill bottles were Hydrocodone, Penicillin, and Xanax. The pill bottles were empty. The trail of blood continued into the common area hallway and down the basement stairs. Photos of the scene were taken by Inv. PICKENS.

JENKINS was located in the basement behind a filing cabinet in the southeast corner. JENKINS had blood all over himself. JENKINS was handcuffed behind his back and the cuffs were double locked. JENKINS was placed into the rear of unit #220 and a squad was called to evaluate his injuries.

While LFD evaluated JENKINS, JENKINS told LFD that he cuts himself regularly and has psychiatric issues relating to that. JENKINS further stated that he broke into the house looking for anxiety drugs. JENKINS then told LFD to "Fuck off." LFD stated that JENKINS wounds were superficial and had already clotted, there was no active bleeding from the wounds.

DANDREA was contacted and he arrived on scene. DANDREA did a walk through of his residence

[redacted] and confirmed that the pill bottles in the kitchen were empty. The full bottles were in the bedroom and had not been disturbed. DANDREA confirmed that nothing was missing from his residence. DANDREA stated that JENKINS does not live with him or SHORTT upstairs. DANDREA further stated that JENKINS has a known drug abuse problem and he does desire prosecution against JENKINS.

JENKINS was booked into LPD jail, booking #LK-08-008345. JENKINS was read his Miranda Rights and refused to answer any questions. [redacted]

[redacted] Due to the issues relating to JENKINS cutting himself earlier in the evening, he was placed on a suicide watch while in custody.
