

	<p>M.O.: By playing the stereo loud enough to cross property lines, causing a noise disturbance.</p> <p>On 10/11/08, at 0224 Hrs, I responded to 1284 Cove Apt #9 on an anonymous complaint regarding loud music. Dispatch advised they had received a couple of phone calls regarding the noise. When I arrived on scene, I could hear the music playing as I reached the second floor landing in the stairwell. The apartment is located on the third floor. The music was extremely loud, and could be heard through out the third floor hallway.</p> <p>After several attempts to gain the residents attention, the music was turned down slightly. I could hear a male and female talking inside. Due to prior incidents at this apartment, the resident is known as SUS/LAWRENCE WILLIAMSON. When I asked WILLIAMSON to come to the door to speak with me, he stated he would not open the door because he was not disturbing anyone. WILLIAMSON stated he thinks people are picking on him. I again tried several times to get WILLIAMSON to answer the door, but he refused.</p>
