Topic Original Report

MO; By pulling out a folding blade knife, opening it in front of a passerby, then closing it and putting it back in his front pocket concealing it from view.

On 10-11-08, at 1822 Hrs., I was detailed to 13201 Madison (Madison Park) on the report of three black juvenile males walking on eastbound on Madison on the south sidewalk and one has a knife concealed on his person. Dispatch advised one was wearing a red shirt, one a tan shirt and the one with the knife was wearing a black shirt, black cap and black backpack.

I stopped the juveniles in front 13201 Madison. I ordered the juveniles to place their hands on the front hood of my auto and not to move. I advised the juveniles of the knife complaint and the juvenile wearing black said he had the knife in his pocket.

I quickly patted down OIV/ , OIV/SAMUEL ADKINS and ARJ I retrieved the folding knife from the right front pocket of and secured it. I placed in handcuffs and placed him in the back seat of my car.

At this point, PO SIDELL, PO D. MCCARTHY arrived and they secured and ADKINS in their cars.

INV. WALLING went to COM/MICHAEL TOWARNICKI's home to speak with him about the incident. INV. WALLING advised me that TOWARNICKI was walking his two medium sized dogs westbound on Madison on the north side just past Clarence. TOWARNICKI said three B/M juveniles were walking eastbound at the same time. TOWARNICKI said he walked to the right as he kept his dogs to that side too. TOWARNICKI said one of the juveniles said "I don't want to fuck with you." At about the same time he saw pull out a large, folding knife, he opened it, closed it and put it back in his pocket as they passed each other.

TOWARNICKI said he was not threatened by but felt uncomfortable that he had displayed the knife. TOWARNICKI said he just wanted the police to know about carrying the knife and did not want to be involved any further.

I mirandized and asked him what happened. gave the same story as TOWARNICKI, except for the knife he was carrying. said he accidentally dropped his knife out of his pocket and never intentionally displayed it. said he did not have any words with TOWARNICKI as they passed each other.

I spoke with and ADKINS about the incident and they said they did not know anything about having a knife on his person.

I arrested for CCW (Misdemeanor) and released and ADKINS at the scene.

I transported to LPD jail, he was booked by C.O. SMITH and placed in a holding cell.

Note, 's mother OIV/TARA PRICE, was out of town and could not be reached. However, said he was staying with his Aunt, OIV/TANZIE HALSELL and she was contacted. HALSELL
