Topic Original Report

M.O. 1: By having a metal pipe, with burnt marijuana residue, in front right pants pocket.

M.O. 2: By being voluntarily intoxicated, on a city sidewalk, while being unable to care for himself.

Sgt. Gannon, Sir:

On 10/11/2008, at 0128 hours, officers were detailed to Lauderdale Ave., south of Detroit Ave., on the report of males arguing and being loud. As I drove S/B on Lauderdale Ave., I observed two males, subsequently identified as ARA/RICHARD P. DAUGHERTY and ARA/PATRICK D. LONG, on the sidewalk in front of 1445 Lauderdale Ave. DAUGHERTY and LONG appeared to be yelling and arguing with each other.

LONG had the strong odor of an alcoholic beverage on/about his person. In speaking with LONG, I observed that he had difficulty standing without support, was slurring his speech, had glassy eyes, and did not know where he was or where he was going. Dispatch advised that he had an outstanding warrant out of Lakewood PD for Contempt of Court. LONG was arrested on the warrant and for DCI. LONG was placed in Unit 209. I transported LONG to LPD, where he was booked into the jail by C/O McCarthy. LONG was issued misdemeanor citation number M41536, for DCI.

Officer Misch spoke with DAUGHERTY. DAUGHERTY had the strong odor of an alcoholic beverage on/about his person. DAUGHERTY had glassy and bloodshot eyes, slurred speech, was unsteady on his feet, and did not know where he was or where he was going. Dispatch advised that DAUGHERTY had an outstanding warrant out of Rocky River PD, for Contempt of Court. DAUGHERTY was arrested on the warrant and for DCI. In searching DAUGHERTY incident to his arrest, officers discovered a metal pipe, with burnt marijuana residue, inside of his right front pants pocket.

DAUGHERTY was not transferred to Rocky River PD due to his being intoxicated. DAUGHERTY was placed in Unit 215, and transported to LPD by Officer Misch. DAUGHERTY was booked into the jail by C/O McCarthy. DAUGHERTY was issued misdemeanor citation number M39810, for DCI, and M41188, for Drug Paraphernalia.
