Topic Original Report

M.O.- By causing serious bodily harm to another, by punching a female, knocking her to the ground at Detroit and Bonnieview, and causing a laceration to the back of her head.

On. 10/11/08, at approximately 0232 Hrs, officers were dispatched to 17100 Detroit, on the report of a female being hit, and lying in the street.

Upon arrival we witnessed a female on the ground in the north crosswalk at Bonnieview and Detroit, bleeding from the back of the head. There were people around her trying to keep her still. She was later identified as VIC/ LAUREN A. GRAY. Squad 2 arrived on scene to treat GRAY, and transported her to Lakewood Hospital. Her condition at the time was unknown, but she was conscious at the hospital.

There was also a black SUV, with plate DRF8912, stopped by an off duty sheriff OIV/HOMER ALLEN. That had people involved with the incident inside it.

We spoke with WIT/ MARILYNN J. SKEGGS, who stated that she saw a male in a blue striped polo shirt bothering a group walking down Detroit. SKEGGS does not know anyone that was involved in the altercation. She stated that the male attempted to slap and punch a male in the group, and continued to harass the group. She then witnessed the female, identified as GRAY, attempt to stop the fight, and the male backhanded GRAY, knocking her to the ground. The male then jumped into a black SUV, and when police stopped the vehicle, she identified the male that was removed from the car, as the male who attacked GRAY. The male was identified as ARA/RICHARD T. PAGAN. SKEGGS provided a written statement.

We then spoke with WIT/ERIN A. BOGORDUS, who stated that she saw a fight break out at the corner of Bonnieview and Detroit. BOGORDUS did not know any of the parties involved in the altercation. She stated that she saw two males fighting, and then another male jumped out of a black SUV and joined the fight. She stated that a male in a blue, striped shirt hit a female and knocked her to the ground. When police arrived she identified the male in a white shirt, identified as PAGAN, as the male who hit the female. BOGORDUS provided a written statement.

We also spoke with WIT/CHAD S. SEDELY, who stated that he had been harassed by PAGAN, who was wearing a blue striped polo. He advised that he is friends with GRAY. He advised that PAGAN was outside of McCarthy's and was yelling. He did not know what he was upset about. He asked PAGAN to calm down and let them pass. They exchanged words and PAGAN threw several punches at him, only landing one punch to the face. He advised that he was not hurt and he did not desire prosecution. He walked away from PAGAN. When he turned around, he saw PAGAN hit GRAY and knock her to the ground. He then stated that the male he witnessed taken out of the black SUV by police was the male who struck GRAY. SEDELY provided a written statement.

It should be noted that all three witnesses stated that a male with a blue striped polo shirt struck GRAY, and that they all stated that the male, identified as PAGAN, was the male who had hit GRAY. Even though he no longer had the blue striped shirt on, all witnesses were positive that PAGAN was the male that struck GRAY.

Officers spoke with the driver, identified as OIV/MEGHAN K. EBERSOLE, who stated that there was no altercation. The front passenger, identified as OIV/NICOLE M. LUCZKOWSKI, advised the same as EBERSOLE. LUCZKOWSKI is PAGAN's girlfriend.

PAGAN was handcuffed behind his back, advised that he was under arrest for Felonious Assault, and transported to LPD. PAGAN denied any involvement in the altercation. PAGAN was booking in by CO. DAN McCARTHY.

INV. DEUCHER responded to Lakewood Hospital to speak with GRAY, where she was being treated by DR. HASTINGS. She stated that she could not recall the incident. GRAY stated that she desired prosecution in this matter. INV. DEUCHER took photos of GRAY's injuries and she signed a medical release form. GRAY had a laceration on the left rear side of her head, and was still being treated by DR HASTINGS, who thought she might also have a concussion.

It should be noted that PAGAN has an active warrant with Rocky River PD for contempt of court. The original charge is not listed. The warrant was confirmed by Sgt CRATES of Rocky River PD and a holder was placed.
