Topic Original Report

Sgt. Gannon, Sir:

On 10/11/2008, at 2302 hours, officers were detailed to the Belle Ave. entrance to Lakewood Hospital, on the report of a male claiming to have been assaulted. On arrival, I spoke to COM/EDWARD M. JUCHNIK. JUCHNIK advised that on 10/11/2008, at approximately 2230 hours, he was walking on the sidewalk on the north side of Franklin Blvd., just west of Lewis Dr., when somebody pushed him in the back, causing him to fall to the sidewalk onto his stomach. JUCHNIK stated that he was then kicked in the right side of his face while he was down.

JUCHNIK claimed that he did not see or hear anybody coming prior to being pushed, and did not get a look at the person(s) who attacked him. JUCHNIK did not know where the attacker(s) came from or went, and stated that they did not say anything to him during the attack. He explained that "they came out of nowhere, attacked me for no reason, and were gone." JUCHNIK then walked to Lakewood Hospital to get treatment for his injuries. JUCHNIK spoke with the hospital's security personnel, who called LPD.

JUCHNIK stated that he had pain in his lower back. A red welt and bruise was visible in that area. JUCHNIK also had a bruise and swelling near his right eye, and a cut on his right elbow, apparently from falling to the sidewalk. JUCHNIK was admitted to emergency room, and treated by Dr. Hastings. I took photographs of JUCHNIK's injuries.

JUCHNIK stated that he had no idea who attacked him, or why. JUCHNIK admitted to having "a couple" of beers earlier. JUCHNIK denied provoking the fight, or doing anything other than "minding his own business".

JUCHNIK desires prosecution in this matter, but was advised regarding solvability.
