N A R R A T I V E	Topic	Original Report
	1	<p>M.O. By entering victim's residence and taking the listed items without the owner's permission.</p> <p>On 10-13-08, at approximately 1343 hours, PO ZBYDNOWSKI and I were detailed to 1232 Giel to speak with parties about someone breaking into their house.</p> <p>On arrival, we spoke with VIC/ANALIA N. DIMIT and VIC/SCOTT M. DIMIT who stated the following. Both SCOTT and ANALIA just moved into the home at 1232 Giel. On 10-13-08, at approximately 0810 hours, both ANALIA and SCOTT left their residence to go to work. ANALIA came back to the house at approximately 1200 hours to find her laptop gone off of the kitchen table. ANALIA then called SCOTT, who also responded home.</p> <p>SCOTT and ANALIA stated they looked throughout the house and did not find the laptop. ANALIA said that she then noticed the listed jewelry missing from their boxes from an upstairs bedroom. She stated she then called LPD.</p> <p>Both SCOTT and ANALIA stated that the house was locked when they left for work. They also told officers that they had not changed the locks to the house after they moved in. All doors were secure and there were no signs of forced entry anywhere outside the home. The listed black hoodie and vest were found on the ground on the outside front porch. ANALIA believed that the clothes may have been left by the suspect, as they belong to neither her nor SCOTT.</p> <p>While walking through the house, SCOTT noticed that the three listed bottles of red wine were also taken from a wine rack in the kitchen. Nothing else was found to be missing at that time.</p> <p>Neither SCOTT nor ANALIA have any suspects in this case. PO ZBYDNOWSKI tried to speak with neighbors at 1228, 1227, 1231, 1236, and 1237 Giel, but there was no answer at the doors.</p> <p>INV GEARY responded to process the scene but found nothing of evidentiary value. The black hoodie and vest were tagged, and placed in locker #18 in the property room at LPD.</p> <p>SCOTT responded to the station to drop off copies of pictures of the listed jewelry and laptop which were stolen. SCOTT said that he would be able to positively identify the stolen items.</p>
