Topic Original Report

MO: By entering into the victim's home through an unlocked front door and removing one laptop computer from an upstairs bedroom without the knowledge or consent of the victim.

Detailed to 12576 Lake Ave. on a report of a home burglarized and a laptop computer taken. On arrival, I was met by the complainant, VIC/WAYNE L. CARNEY who advised the following.

CARNEY advised that he and his wife live in the home with his 92 year old mother-in-law. He advised that his mother-in-law, OIV/MARY C. SCHLARB, occupies the finished third floor in-law suite of the home. CARNEY went on to say that he left home for work on this date at approximately 0900 hours. His wife returned home from a morning meeting at approximately 1330 hours. The family also has a housekeeper come to the house for cleaning every Monday.

CARNEY advised that when he returned home from work on this date at approximately 1700 hours, he walked up to his bedroom and was going to use his laptop computer. The laptop computer had been located on top of an antique wooden desk in the bedroom. When he went to use the computer, he noticed that it was no longer there. All of the power cords were gone as well. CARNEY checked with his wife to see if she had moved the laptop. She told him that she had not. He then was able to speak with his housekeeper, who was no longer at the house, and learned the following.

The family always leaves the front door to the home closed but unlocked on Mondays for the housekeeper. When she arrived on this date at approximately 1100 hours, she noticed that the front door was not only unlocked, but also wide open. She did not think anything of this at the time. She then continued to clean the house as usual and left at approximately 1330 hours. CARNEY said that he spoke with the housekeeper regarding the computer. She told him that she did not remember seeing the computer on his desk when she cleaned the bedroom on this date.

CARNEY advised that the family has had this same cleaning lady coming to the house for years and they all trust her explicitly. CARNEY also advised that there have been times in the past when the family was going out of town for a few days and the housekeeper would come over to spend time with his mother-in-law, SCHLARB, to keep her company and make sure she had something to eat. He stated that he would never suspect her of stealing from him.

CARNEY did advise that SCHLARB has blood drawn every three weeks. He advised that a company called CPY/MEDLAB sends a phlebotomist to the house to draw the blood. Each time they come, they call in advance to let the family know that they are coming. CARNEY added that his wife works from an office in the basement and will unlock the front door when they call to advise that they are coming. He said that they usually arrive, let themselves in through the front door, walk up to the third floor in-law suite, draw SCHLARB'S blood, and leave. He advised that it is not always the same person who draws the blood, but there have been people who have come to the home more than once.

After learning that his laptop computer was missing, CARNEY spoke with SCHLARB, who was home all day, asking if she had seen or heard anything. SCHLARB told him that she had seen "the skinny lady who draws my blood" come up to her suite earlier in the day. She looked at the lady and made eye contact with her. The lady then turned around and walked back downstairs. That is the last SCHLARB saw of this female.

I was also able to speak with SCHLARB. She gave me an identical account of what she had seen. She could not remember the lady's name or what she was wearing on this date. She was certain that it was the same lady who had come to draw her blood the previous month, however. SCHLARB did not see or hear anyone else in the home throughout the day, except for the housekeeper. She described the female as being a very pretty black female.

CARNEY stated that after leaving, the phlebotomist will always leave a receipt for the blood work. He was able to locate the receipt for the last blood draw in September. The company that draws the blood is CPY/MEDLAB. The phlebotomist that drew the blood that time signed the paperwork "Jessica."

CARNEY was not able to give any specific model or serial number information for the laptop computer. He advised that it was a black E-Machines computer and was purchased at a Best Buy store in Virginia with his Best Buy credit card. He was going to attempt to contact Best Buy in an attempt to locate the model and serial numbers for the laptop. He advised that he checked throughout the rest of the house and could not locate anything else missing, even though there are numerous other valuable small electronics items (Ipod, Bose Wave radio, etc.) in plain view.

INV. CRUMLEY arrived for ET. He was not able to locate anything of value.

I was able to call MEDLAB in an attempt to determine the identity of "Jessica." I was able to speak with the Human Resources Manager and was able to obtain complete MNI for SUS/JESSICA WALKER. He did advise that they conduct a complete criminal background investigation on all of their employees prior to their hire date. She has worked for MEDLAB since 1-2-08 and they have never had any problems with her. He also added that she has been drawing SCHLARB'S blood for months and she is a white female. The last time a black female drew SCHLARB'S blood was in March 2008. He was already aware of this report prior to my calling because CARNEY had contacted them as well. He was shocked to hear this information. He advised that he would be completely surprised if WALKER was involved in this Burglary. He also added that their company is involved in Medicare billing and they have very accurate records, due to federal regulations, and are able to show exactly who was at the CARNEY home, on which dates, and at what times.

CARNEY advised that he would desire prosecution in this matter. CARNEY was advised to contact this department with the complete MNI for his housekeeper.
