Topic Original Report

MO: By engaging in sexual conduct in a public place under circumstances which their conduct is likely to be viewed by and affront others.

Lt. Sprague, Sir:

On 10/13/2008, at approximately 1258 hours, Inv. Crumley and I were detailed to Madison Park, in the area of the softball dugout, on the report of a male and female engaging in sexual activity. Their actions from approximately 1250 to 1258 hours were viewed by Lt. Sprague and Inv. Crumley on the Madison Park surveillance camera system at Lakewood PD. Lt. SPRAGUE advised that he observed the couple sitting in the dugout with the female sitting partially on the male's lap/left leg. The male had his right hand under the waistband/inside of the female's pants and was reaching down masturbating her with his hand. He was also observed to be grabbing the female's left breast both on top of as well as underneath her shirt. After the female got off of the male's lap she adjusted her clothing and then sat back down next to the male who, at this point in time, had his erect penis exposed. The female then proceeded to bend down into the male's lap and was performing oral sex on the male. She did this briefly two times and then the male proceeded to masturbate himself until he saw my police car pull into the park and then he stopped.

Lt. Sprague described the male as having a medium build, black medium length hair, medium complexion and wearing a white hooded sweatshirt. Lt. Sprague described the female as having a medium build, shoulder length hair, medium complexion and wearing a striped long sleeved shirt. I arrived on scene and located a male and female matching the descriptions provided to me by Lt. Sprague. They were located in the dug out area of the West Madison Park soft ball field. Inv. Crumley arrived on scene just minutes after me.

Inv. Crumley confirmed that the male and female were the two parties who were seen on the surveillance video. I obtained the male's index information. I ran him in my MDT and identified him as ARA/ ATEF WISSA via his BMV image. Inv. Crumley obtained the female's index information. He attempted to identify the female, but was unable to do so as she has no Ohio Identification Card or Ohio Driver's License Photos on file and said she did not have a SSN on file either.

WISSA was issued Misdemeanor Citation M41428 for Public Indecency. He was released on citation as his Identification was positively confirmed.

ROUFAIL was issued Misdemeanor Citation M41427 for Public Indecency. As a result of being unable to positively confirm ROUFAIL's identity, she was secured in the rear Car 215. I transported ROUFAIL to the Lakewood City Jail where she was booked on the Public Indecency charge. A family member responded to the station and provided ROUFAIL's passport that included her photograph. ROUFAIL was positively identified via this passport.
