Topic Original Report

Sgt. Spaetzel, Sir:

On 10/13/2008, at approximately 0812 hours, Inv. Crumley, Officer Zbydnowski, Officer Bly and I were detailed to the area of 1588 Lakewood (Upper) on the report of a possible overdose. We arrived on scene with Lakewood Paramedic squad members and spoke with SUB/ EARL BLANKENSHIP. He advised the following.

On 10/13/2008, at approximately 0800 hours, BLANKENSHIP, OIV/ , OIV/ and SUB/ LISA SALAJCIK were sitting in the living room area of the residence. SALAJCIK stood up and began to walk towards the front door of the apartment. SALAJCIK collapsed, when she was approximately two feet from the front door, into a semi conscious state. SALAJCIK was unable to pick herself up off the floor and although BLANKENSHIP tried to assist her he was also unsuccessful in getting her up. BLANKENSHIP then called LPD to report this incident and to request medical assistance.

Lakewood Paramedics transported SALAJCIK to Lakewood Hospital. and were released to their adult sister, OIV/ BETH VEALEY.

While on scene, I ran BLANKENSHIP's social security number with dispatch. Dispatch advised that he had an active warrant with GOV/ GARFIELD HEIGHTS PD. I advised BLANKENSHIP of this warrant, placed him under arrest and secured him in handcuffs. Dispatch confirmed this warrant as good. Officer Zbydnowski and Officer Bly escorted BLANKENSHIP from the apartment and secured him in the back of Car 206. He was taken to Steelyard Commons where GARFIELD HEIGHTS PD officer took custody of BLANKENSHIP. He was secured in Car 3414 and transported to GARFIELD HEIGHTS PD from this location.

SALAJCIK was treated by Dr. Nelson at Lakewood Hospital. I spoke to Dr. Nelson and he advised that SALAJCIK was given charcoal and IV fluids for treatment. Her exact diagnosis is unknown at this time.

It may be noted that SALAJCIK was prescribed Vicodin on 10/9/08. It is unknown as to whether or not she ingested this medication prior to my arrival. This medication was taken to Lakewood Hospital along with SALAJCIK to be reviewed by medical personnel.

I attempted to speak to SALAJCIK while at the hospital. She was incoherent and was unable to provide a statement.
