

Topic Original Report

M.O./1: By displaying a knife and taking an iPod from the VIC.

M.O./2: By knowingly having a knife concealed in the waistband of his pants.

M.O./3: By being in possession of two stolen cell phones.

M.O./4: By being in possession of prescription medications Pennicillin and Metronidazole without legal provision.

Lt. Warner, sir:

On 10/14/2008, at 1827 hours, officers were dispatched to the area of Edgewater and Homewood on a call from COM/MARIE LOWTHER stating two males on bikes had taken an iPod from a juvenile. LOWTHER also stated the two males threatened the juvenile with a knife and left the area S/B on Homewood. Officers began to check the area for the suspects.

Upon arrival at 13473 Edgewater, I spoke to VIC/ who stated the following:  
 At approximately 1815 hours, was jogging E/B on Edgewater as part of his cross country team practice. was listening to the listed grey iPod while he was jogging.  
 WIT/ and WIT/ were at the back of the team, and all other teammates and coach OIV/ were running ahead.  
 and observed two males on bicycles on Edgewater at Estill. These males were described as a W/M and a B/M, both wearing matching blue jackets with a red design. As and passed Homewood, the males on bicycles approached them. The W/M grabbed wrist and stated, "Gimme the iPod, nigga." The W/M also pulled up his jacket, revealing the handle of a knife which was in his waistband. stated the knife handle was covered in some type of grey tape or cloth. The W/M took ' iPod and both males on bicycles left the area S/B on Homewood. went to the nearest house, 13473 Edgewater, where LOWTHER contacted Lakewood PD. As I spoke to , he was still holding the earphones from the iPod.

Inv Crumley located two males riding bicycles on Franklin at Cohasset which matched the given description. Both males were wearing matching blue jackets with a red design. Due to heavy traffic, Inv Crumley was finally able to stop one of the males on Madison at Cohasset. The male was identified as ARJ/ was in possession of a grey iPod with no headphones. was also in possession of the listed blue Samsung cell phone, which was later found to be stolen from Parma. It should be noted that is listed as a W/M, but he resembles a light skin B/M.

While on Madison, Inv Crumley was approached by COM/PETER FEHRENBACH, who stated LARGE and had just assaulted his son, OIV/ moments ago on Lewis. See Inv Crumley's supplement for further information (01-08-008325).

PO Smykowski and PO Hilfiker stopped the other male, identified as ARA/SEAN LARGE, on Madison at Alameda. LARGE had the listed knife in his waistband, above his right front pocket. The handle of

the knife was visible above his waistband and was wrapped in grey duct tape. LARGE was also in possession of the listed grey Samsung cell phone, which was later found to be stolen from Parma. LARGE also had the listed blue bandana and prescription medication. See PO Hilfiker's supplement for further information.

LARGE and [redacted] and [redacted] were transported to Madison where they positively identified [redacted] as the two males from Edgewater. [redacted] also identified the iPod as the one that was taken from him.

The iPod was photographed, tagged and released to [redacted] father, OIV/DANIEL JOSEPH SWEENEY.

By calling numbers stored in the memory of the cell phones, Inv Crumley was able to speak to the owners of the cell phones. Inv Crumley learned that the cell phones were taken during a robbery at State Road Park in Parma earlier today. Galinas #72 at GOV/PARMA PD was informed of the recovered cell phones and given this report number. Galinas confirmed the cell phones were taken during a robbery at State Road Park today at approximately 1430 hours. Galinas requested an investigatory hold on LARGE. Galinas supplied a PARMA PD report number of 0829001.

The knife was tagged and secured in property room locker 13 by PO Hilfiker. The grey Samsung cell phone found on LARGE was tagged and placed in property room locker 17 by PO Hilfiker. I tagged the blue Samsung cell phone found on [redacted] and placed it in property room locker 10. I tagged the prescription medication and placed it in the property room drug chute. I also tagged the blue bandana and placed it in property room locker 10. The bicycles LARGE and [redacted] were riding checked NIF for stolen through NCIC and the bike board by Dispatcher Sykora. The bicycle ridden by LARGE was tagged and secured in the property room by PO Hilfiker. The bicycle ridden by [redacted] was tagged and secured in the property room by Inv Geary.
