Topic Original Report

M.O.: By entering apartment, through unknown means, and taking electronics and jewelry without owners' permission.

Lt. Warner, Sir:

On 10/16/2008, at 1959 hours, Inv. Register and I were detailed to 13434 Madison Ave., on the report of a burglary. On arrival, I met VIC/DUSTIN M. HAYDEN, and his wife, VIC/JACQUELYN M. HAYDEN.

DUSTIN advised that he left the apartment for work, at approximately 1300 hours, on 10/16/2008. DUSTIN believes, but is not entirely sure, that he locked the apartment's front door and rear door, as well as the rear door to north side of the building, which he shares with an upstairs neighbor. DUSTIN returned to the apartment, at approximately 1700 hours, on 10/16/2008. JACQUELYN stated she left the apartment at approximately 0800 hours, on 10/16/2008, and returned home at approximately 1900 hours the same day.

Shortly after arriving home, DUSTIN noticed that a small bookcase, normally kept in the bathroom, had been overturned, with its contents spilled out onto the floor. The bathroom is in the rear of the apartment, with a window overlooking the back yard. The bookcase is kept under the bathroom window. Having kept the bathroom window open prior to leaving earlier in the day, DUSTIN replaced the bookcase and its contents, thinking that wind had knocked it over.

DUSTIN then noticed, at approximately 2130 hours, that a key, normally kept in the deadbolt lock inside the front door, to the south side of the apartment, was missing. Finding this suspicious, DUSTIN explored further, finding that his Nintendo Wii, as well as one video game, were missing from the living room. The living room is located in the northeast corner of the apartment. Additionally, a watch, JACQUELYN's jewelry box, and a piggy bank with approximately \$10 in assorted U.S. coins, all were missing from cabinets in the hallway just outside their bedroom, in the southwest corner of the apartment. The jewelry box held a diamond necklace, two pair of earrings, two rings, and two camera memory cards. DUSTIN then called LPD.

No signs of forced entry were observed to any of the doors or windows leading into the apartment. It does not appear that entry was gained through the bathroom window. DUSTIN and JACQUELYN advised that they have occasionally left their doors unlocked in the past, and stated that they may have left one or more of them unlocked prior to leaving the apartment on 10/16/2008. It is thus unclear exactly how parties gained access to the apartment.

DUSTIN stated that a number of drawers to various dressers and cabinets, including the ones from which the indexed property was taken, appeared to have been searched, as their contents had been moved around. DUSTIN advised, however, that none were open when he returned home. Whoever entered the apartment thus appears to have closed them prior to departing the apartment.

Inv. Register processed the scene for evidentiary purposes, though no prints were lifted.

We spoke to the upstairs neighbor, who advised that he did not see anything suspicious. We contacted the Record Exchange in Lakewood; the manager advised that they had not purchased any

Nintendo Wii's during the relevant times.

DUSTIN did not have a serial number for the Nintendo Wii, but would provide it to LPD if/when he can locate it.

DUSTIN advised that nobody else, to his knowledge, has keys to the apartment. DUSTIN and JACQUELYN have no suspects in this matter, but desire prosecution in the event one is located. They were advised regarding solvability.

They were advised to contact their landlord to have their locks changed.
