N A R R A T I V E 1	Topic	Original Report
	<p>M.O.-By being in possession of 8.86 grams of counterfeit crack cocaine. M.O.-By removing the listed BB Gun, currency and cell phone form the victim's apartment without the consent of the owner.</p> <p>On 11-16-08, at Approx. 2212 hours, cars were detailed to 1415 Wyandotte #101 on the report of a male having stolen a cellular phone and currency from the apartment. The complainant, VIC-BROWN, advised dispatch that she met the male over a chat line and gave a description of the male and his clothing. BROWN advised that she met the male at the W.117 St. rapid station so I began checking the roads in the area in an eastbound direction. While checking the area, I located a male matching the description at the bus stop on the southeast corner of W.117 and Madison.</p> <p>I stopped the cruiser and approached the male to speak with him. The male verbally identified himself as ARJ- . I asked if he just been at a female's apartment on Wyandotte, and he stated that he had. I advised that BROWN stated he stole her cell phone and some money from the apartment. denied the allegations and consented to a search of his person. During the search, in the inside jacket pocket, I located the listed counterfeit crack cocaine. There was one large chunk wrapped in a baggie, that is consistent with how crack cocaine is packaged. There were also numerous little rocks of what appeared to be crack cocaine that were loose in the pocket.</p>

was secured in handcuffs at this time and advised he was under arrest. Inv. Register arrived on scene at this time.

While securing the suspected crack cocaine, Inv. Register continued the search of [redacted] and located the listed \$44.00 in currency in [redacted]'S jeans pocket. [redacted] was advised of his rights in the presence of Inv. Register and stated that he understood. PO MISCH arrived on scene and [redacted] was secured in unit 212 at this time. I began checking the area for the cell phone that was reportedly taken and looked over a wall to the west of where [redacted] was standing. In a grassy area over the wall, we located the listed cell phone w/ charger and BB Gun. BROWN was able to identify the phone and the BB gun as hers when she arrived on scene a short time later.

PO Gampfer responded to the scene for BROWN to identify [redacted]. BROWN gave a positive identification of [redacted]. I spoke briefly with BROWN and she advised the following; She met [redacted] on a telephone chat line earlier in the day. During the chat, they decided to meet at the rapid station at W.117 and Madison. BROWN walked down to the rapid station and met [redacted], whom she knew as [redacted]. The two walked back to her apartment and had sexual relations. BROWN went to use the bathroom and when she came out she heard her apartment door slam. She looked inside the apartment and realized that [redacted] was gone. While looking in her bedroom, she also noticed that her cell phone and \$45.00 was gone. She ran across the street and called the Police. BROWN did not see which way [redacted] left, so she gave us the physical and clothing description of him. BROWN advised that the money was on her dresser and [redacted] was holding the cell phone prior to her going in the restroom. BROWN was unaware that [redacted] had also taken the listed BB Gun that she kept in the night stand. PO GAMPFER took BROWN back to her apartment and obtained the attached written statement from her. PO GAMPFER released the money and cell phone w/ charger to BROWN after she took photos of the items. We were unable to find the missing dollar that was also taken, so only the \$44.00 was able to be given back to BROWN.

[redacted] was transported to the station where he was booked into the jail by C.O. D. McCarthy. The suspected crack cocaine was tested with a test kit and would not give a positive test result for crack cocaine. [redacted] was ultimately charged with Poss. of a Counterfeit Controlled Substance and Petty Theft. Due the fact that he is a juvenile, no misdemeanor citations were filled out, per policy.

[redacted] gave the following account of the night's events; [redacted] advised that he did speak with BROWN on the chat line and they eventually met. [redacted] stated that while walking back to the apartment, another black male picked them up in a black Honda and drove them to BROWN'S residence. This male stayed at the apartment while [redacted] and BROWN "fooled around". BROWN then told [redacted] that another male was coming over from the east side and bringing drugs so they had to leave. [redacted] stated that the other male took the gun and cell phone and they left the apartment. [redacted] stated that the male dropped him off at W.117 and Madison and was talking with him when they observed me checking the area. The male threw the BB gun and cell phone up over the wall and gave his coat to wear. The male told [redacted] that the crack that was in the pocket was fake and he had to sell it for him. The male then left the area. [redacted] could offer no further details on this unknown male.

The BB gun and counterfeit crack cocaine were confiscated, tagged and secured in the property room. The counterfeit crack weighed 2.6 grams (gross) and 6.26 grams (gross). The counterfeit crack was placed in the property chute and the BB gun was secured in locker #12. [redacted] has no CCH.


