	<p>M.O.: By having a plastic bag, containing 15.0g of marijuana, under his vehicle's driver's seat, while admitting to owning same.</p> <p>Lt. Warner, Sir:</p> <p>On 10/16/2008, at 0215 hours, I was behind the indexed vehicle, E/B on Lake Ave., at W. 117th St. A check of the vehicle's license plate revealed that the listed owner, ARA/PAUL M. GONZALES, had a suspended driver's license, Non Compliance Suspension, with FRA from 10/21/2005 to 10/21/2008. I also observed that the driver was not wearing his seat belt. As the driver matched the owner's description, I activated my emergency lights, and stopped the vehicle at Lake Ave. and W. 116th St.</p> <p>The driver identified himself as GONZALES. GONZALES stated that he was aware that his license was suspended. GONZALES advised, however, that he was heading to Christie's nightclub in Cleveland to pick up his girlfriend from work, and thus not due to any emergency.</p> <p>GONZALES was issued traffic citation number D165179, for DUS and Failure to Wear a Seatbelt. While conducting a routine inventory of the contents of the vehicle prior to towing it, I observed a plastic bag of marijuana beneath the driver's seat. GONZALES admitted that the bag, which he advised was marijuana, belonged to him. GONZALES was then issued misdemeanor citation number M41537, for Drug Abuse and released.</p> <p>GONZALES' Ohio driver's license was seized, to be forwarded to BMV. The marijuana, 15.0G, was transported to LPD, and secured in the property room drug chute.</p> <p>GONZALES has a CCH, FBI number [REDACTED], BCI number [REDACTED], showing prior convictions for breaking and entering, aggravated assault, domestic violence, aggravated menacing, and assault.</p>
