N A R R A T I V E 1	Topic Original Report	<p>On 10-17-08, at 1931 Hrs., an unknown male called for an ambulance in the area of Hird Ave and Detroit Ave. The male did not state the nature of the emergency.</p> <p>I responded to the scene with P.O. Harner and Squad 3. They were on scene prior to my arrival.</p> <p>I spoke with (SUB) MARIO JENKINS. He advised he was walking S/B on Hird Ave from the railroad tracks when he felt a brick hit the back of his head. JENKINS stated he did not see who threw the brick and could give no description.</p> <p>JENKINS stated he was walking on the sidewalk on the west side of the street. He stated he was going to visit his friend, (OIV) CAMERON C KELLEY.</p> <p>JENKINS stated the brick was tan in color and rectangular in shape. He advised the brick should still be on the sidewalk. P.O. HARNER and I tried to locate this brick, but were not able to do so.</p> <p>JENKINS had a small laceration on the top of his head that was bleeding. I took photographs of his injury.</p> <p>JENKINS desired no further police involvement. He was transported by paramedics to Lakewood Hospital's E.R. where he was treated by Dr. Hastings. He was later released.</p> <p>JENKINS did have an active warrant out of (GOV) BRECKSVILLE P.D. for DWUS. They were not able to pick him up.</p>
