

<b>N A R R A T I V E  1</b>	Topic	Original Report
<p>On 10-18-08, at approximately 1241 hours, PO ZBYDNOWSKI and I were detailed to 1473 Cohasset to speak with the resident about some jewelry missing from her home.</p> <p>On arrival, we spoke with COM/NAHIDA D. FARUNIA who stated the following. She and her soon to be ex-husband, OIV/DAWOD FARUNIA, have been going through a divorce since 2006. Both were at court two weeks ago. During the proceedings, DAWOD started talking about the jewelry in question, stating that he believed both he and NAHIDA should share it.</p> <p>On today's date, 10-18-08, NAHIDA noticed that the listed jewelry was missing from her upstairs bedroom jewelry box. She stated that she keeps it in the jewelry box in a red pouch, which was empty. NAHIDA said that she had not seen the jewelry in two weeks, since going to court with DAWOD.</p> <p>NAHIDA stated that she keeps the side door of her home unlocked so that her kids can get into the house after school. There were no signs of forced entry to the home. NAHIDA stated that DAWOD knows that she keeps the back door unlocked.</p> <p>It should be noted that NAHIDA showed us a temporary restraining order from 2006, listing DAWOD as the subject, who is not allowed to have contact with NAHIDA, or her children until 2011. Also, DAWOD has been living in the office at his business.</p> <p>NAHIDA does not have any other suspects in this matter. She believes that DAWOD took the jewelry since he mentioned it in court and knows where the jewelry is kept in the bedroom.</p>
