Topic Original Report

M/O:By being in possession of a cigarette box which contained a plastic baggie with 6.7 grams of marijuana inside of it.

Lt. Warner Sir,

On 10/18/08, at approximately 0227 Hrs, I observed the listed Dodge Caravan travelling S/B on Madison with only one headlight illuminated. I stopped the vehicle as it left Lakewood, S/B on W117th. As the driver, later identified as OWN/LYJESTA AGEE was pulling to the curb, I observed a box of what I believed to be Newport cigarettes, being thrown out of the front passenger window. I advised SGT. KAUCHECK, who was arriving to assist, about the cigarette box.

AGEE was advised of the reason for the stop.

SGT. KAUCHECK advised that he had located the listed Newport cigarette box, and the it contained a plastic baggie with marijuana in it. P.O. SCHAD and INV. ALLEN also arrived to assist.

AGEE, and the two passengers of the vehicle were asked to exit. The front passenger was identified as ARA/DEONTE BENNETT. OIV/MIQUEL WARFIELD was in the rear of the vehicle, in center of the bench seat. All three consented to a search of their person, with no contraband being located. There was no other contraband located in the vehicle.

AGEE stated that he was unaware that anything had been thrown out of his vehicle. WARFIELD also stated that he was unaware that anything had been thrown out of the vehicle. Both appeared to be telling the truth.

BENNETT also stated that he did not know anything about the marijuana, however it appeared as though he was being dishonest. P.O. SCHAD advised that while searching BENNETT, he had located a plastic baggie in his right front pants pocket. This baggie was identical to the one that the marijuana was in.

BENNETT was issued Misdemeanor citation #M41812 for Drug Abuse, and traffic citation #D164733 for Littering From A Motor Vehicle.

AGEE was issued traffic citation #D164733 for One Headlight.

All three were then released.

The cigarette box containing the marijuana was confiscated as evidence. I later weighed the marijuana and found there to be 6.7 grams in the baggie. I tagged the box, baggie, and marijuana, and secured them in the chute in the LPD property room.
