Topic Original Report

MO; By cutting/removing screen on exterior of double hung window, prying on side of window breaking lower double pane window partially out, then placing a thin metal type of tool underneath base of window to lift it up as the window was unlocked.

On 10-21-08, at 1656 Hrs., I was detailed to 11859 Edgewater #207 on the report of a Burglary. On arrival, I spoke with VIC/IAN DOWLING, who said he came home from work this afternoon and found his west back door open and the west porch window partially broken out.

DOWLING said he checked his home and nobody was inside. DOWLING said he resides with his wife, VIC/TIFFANY DOWLING and she was presently at work. IAN said their infant child's closet was rifled through, but nothing was taken. IAN said their bedroom had been completely rifled through and IAN said they do not keep valuables in the home.

IAN said that it appears that nothing was taken from the home.

I checked the other windows in the building and none had any damage done to them. IAN's back porch is partially enclosed in the wooden stairwell. The point of entry into IAN's home is not visible to any of his neighbors.

IAN has no suspect(s). I advised IAN of the low solvability factors of this report. However, IAN said if a suspect(s) were located he would prosecute in this matter.

It appears the suspect(s) walked up the west stairwell and stuck a thin, metal tip, type of tool into the side of the window and partially broke it out. However, only a small, jagged hole was in the double pane window. It does not appear that the suspect(s) could have reached into and upwards to unlock the new window. It appears that the window was not locked. The suspect(s) then placed a thin metal tip type of tool underneath the extreme left base of the window and lifted it up to enter through the window. The suspect(s) left out the back door of the home next to the point of entry into the home.

I knocked on #107 and #307 in the rear stairwell and nobody answered the doors.
