<p>MO:By being in possession of 1.84g of marijuana.</p> <p style="text-align: center;">Sgt. WILKINS Sir;</p> <p>Dispatched to Cove Park on the report of three males smoking marijuana. COM/DIANE KALUSZYK described them as two black males and one white male. One of the black males had on a red hoodie and baseball cap, and the white male has long blonde hair and was on a bike. I located the males standing next to the playground equipment in the N/W corner of the park.</p> <p>As I approached the males, I could smell a strong odor of burnt marijuana in the area. One of the males, later identified as ARA/DAVID MCCLENTON, lit up a black and mild cigar when he saw me approaching. The other black male was identified as OIV/ and the white male on the bike was identified as OIV/.</p> <p>I advised the three males of the complaint, and all denied smoking marijuana. They were advised that I was going to be checking all of their persons. I started to check 'S pockets, and while doing so, MCCLENTON began emptying his pockets and throwing items on the ground. I told MCCLENTON to stop several times, but he continued. At one point, I saw MCCLENTON throw the listed baggie of marijuana onto the ground by his feet with his right hand.</p> <p>I picked up the marijuana just after finishing searching and checked MCCLENTON for further drugs with negative results. also was checked and found to have no contraband on his person. The area around these males was checked and nothing further was found.</p> <p>MCCLENTON was issued citation M40800 for Drug Abuse. He advised that he had been smoking the marijuana through a "shell" of a black and mild. MCCLENTON was released on citation. 'S bike did not have a serial number on it. Dispatch checked the serial number and it came back NIF as stolen. The three males were advised that they were free to leave and that the bike was going to be confiscated. was told how he could get the bike out of the property room.</p> <p>The bike was confiscated, tagged, and secured in the property room. The stolen bike board checked negative for possible matches. The marijuana was tagged, weighed, and secured in the drug chute.</p>
