Topic Original Report

MO: Refusing to leave Lakewood Hospital after being told several times to do so.

Lt. Warner, Sir:

On 10-22-08, at 0217hrs, officers were detailed to 11859 Edgewater #304 on a report of a female, later identified as OIV/JULIA M. MOHR, wanting to go to the hospital to speak to a doctor. MOHR advised Inv. Mladek and I that her boyfriend, ARA/JOHN M. CAMERATTA, was inside her apartment sleeping. MOHR advised, her apartment was unlocked and she wanted officers to advise CAMERATTA she was going to the hospital. MOHR also wanted CAMERATTA advised not to respond to the hospital due previous confrontations they have had during the day. MOHR advised, CAMERATTA does not live with her in her apartment, but he was ok to sleep there for the night. MOHR was taken to the hospital by Lakewood Squad 3.

Inv. Mladek and I responded to apartment #304 and spoke with CAMERATTA. CAMERATTA was advised MOHR was going to Lakewood hospital. CAMERATTA was also advised not to respond to the hospital per MOHR. CAMERATTA became upset and began to put on his jacket. CAMERATTA was again advised he was not to go to Lakewood hospital. CAMERATTA said he was going regardless what officers told him. Inv. Mladek and I left the apartment.

On 10-22-08, at approximately 0300 hrs, I was on my way to an unrelated detail and I observed CAMERATTA walking west on Franklin at Olivewood. At 0312 hrs, officers were detailed to Lakewood Hospital on a report CAMERATTA arrived at the hospital. At this time, Sgt. Gannon, PO. Leanza, and I responded to Lakewood Hospital. PO. Leanza and I spoke to MOHR who again advised she did not want CAMERATTA at Lakewood Hospital to see her. I spoke to the security guard on duty, COM/KEVIN C. BERRY and advised him of the situation. BERRY advised he did not wish CAMERATTA to be on Lakewood Hospital property in order to prevent further conflicts between CAMERATTA and MOHR.

Sgt. Gannon, PO. Leanza and I spoke with CAMERATTA. I advised CAMERATTA, MOHR or Lakewood Hospital did not wish for him to be on the property and he would have to leave until MOHR was released. CAMERATTA refused to leave and said he was there to visit MOHR. CAMERATTA was again advised to leave the property or he would be arrested for criminal trespass. CAMERATTA again refused to leave. CAMERATTA was advised two more times and he continued to refused. CAMERATTA was placed under arrest by me for criminal trespass, searched, and placed in the rear of car 220. CAMERATTA became argumentative during the arrest. CAMERATTA was eventually transported to LPD jail.

CAMERATTA was booked in by PO. Leanza and me. CAMERATTA advised he was having chest pains and wished to go to the hospital. Lakewood squad 3 responded to LPD and transported CAMERATTA to Lakewood ER. Once CAMERATTA was admitted to the ER, he became argumentative again by calling officers and hospital staff names. CAMERATTA eventually admitted to officers he faked his complaints. CAMERATTA was discharged by Dr. Nelson and transported back to LPD.
