Topic Original Report

MO: By being in possession of a hypodermic needle, To Wit: 1 Terumo 1cc hypodermic needle.

On 10-23-08, while on patrol, I observed the listed vehicle eastbound on Detroit operating with its bright lights illuminated. I stopped the vehicle on Detroit at Cove. SGT. L. WILKINS, PO MAURER and P.O. SCHAD arrived to assist with the stop. The driver of the vehicle was identified as (ARA)GAGLIARDI, ALYCIA and she was advised for the reason of the stop. The vehicle listed to GAGLIARDI's mother, (OWN) STRAHCA, LARRAINE.

In speaking with GAGLIARDI, she stated that she was at (OIV)FLOWERS, ANTHONY apartment on Clarence tutoring him for a GED test. GAGLIARDI stated that she was a teacher for the Berea School system. In speaking with FLOWERS, he stated that he lived on E.90th in Cleveland and GAGLIARDI was taking him home.

In checking both parties through the computer, they were both found to have extensive CCH's for drug offenses (F). I spoke with GAGLIARDI again and she now explained that she is currently suspended as a teacher. GAGLIARDI maintained that she was tutoring FLOWERS for a GED test. GAGLIARDI was advised that she was not going to be cited for the equipment violation and was free to leave. I then asked GAGLIARDI if I could search her vehicle for any contraband.

GAGLIARDI consented to a search of her vehicle. During the search of the vehicle, I located the listed pink eyeglass case in the center console. Inside the case was the hypodermic needle. In speaking with GAGLIARDI, she stated that her son is diabetic. GAGLIARDI stated she had a card to prove she could possess the hypodermic. GAGLIARDI was unable to locate the card.

GAGLIARDI was issued citation #M40675 for Possession of Hypodermic and then released at the scene. The needle was confiscated and taken to the station. At the station, the needle was tagged and the placed down the chute located in LPD's secured property room.
