**Topic**

MO: By using cutters to cut cords in exam room #17 of Lakewood ER, causing the equipment to not function.

10-24-08, Inv. Malloy and I were detailed to VIC/ Lakewood Hospital ER on report that a patient had gotten confrontational with a doctor and pulled a knife on him. Upon arrival, I was flagged down by hospital security, who advised that the male had left the hospital and was walking east on Detroit. The male was described as having dreadlocks, wearing a grey hoodie and carrying a bag. I advised Inv. Malloy of the description of the male and he was located at Detroit/ Lincoln.

Upon stopping the male he was patted down for weapons and none were located. He was identified as ARA/ CARLOS ROSALES. ROSALES stated that he went to the ER this morning because he felt cold and numbness in his lungs. He stated that his asthma medication had been stolen from him and he wanted to be looked at by a doctor. ROSALES stated that a doctor came in and before looking at him, stated that there was nothing wrong with him and told him he had to leave. ROSALES stated that he never threatened anyone and did not have a knife.

Ofc. Thibodeaux responded to the hospital while we detained ROSALES. Ofc Thibodeaux advised that the shift that was on duty at the time of the incident had left. He was able to contact Dr. Nelson, who was the attending physician, at home. He stated that ROSALES was verbally hostile but no threats were ever made and there was no incident involving a knife.

It was learned that when ROSALES was left in exam room 17 alone, to change into a hospital gown, when the damage occurred and ROSALES then left the hospital. Ofc. Thibodeaux advised that one of the cables that were cut was for the television remote/ and nurse call monitor. The other cable was a computer monitor cable.

Ofc. Thibodeaux advised that he spoke with the hospital administrator, COM/ HOWARD DORENKOTT who advised that he desired prosecution for the damage to the hospital property. Ofc. Thibodeaux took photos of the damaged items and they were later retrieved by Inv. Malloy, tagged and placed into secured storage.

ROSALES was placed under arrest for vandalism. His plastic garbage bag was searched and the listed cutters was located. ROSALES stated that he uses them to cut his toe nails and denied doing any damage to hospital property. Inv. Malloy took possession of the cutters, tagged them and placed the cutters into secured storage. I transported ROSALES to the station where he was booked by CO Bunner.
