N A R R A T I V E 1	<p>Topic Original Report</p> <p>MO:By giving two different names and DOB'S to the police in order to conceal his identity.</p> <p>Lt Warner Sir:</p> <p>On 10/25/08 officers were detailed to 1575 Wagar on the report of an MVA with injuries. On arrival I spoke to the driver of unit #1, later identified as SUS/DAVID HAGGARD. HAGGARD said that he did not have his Ohio DL on him at the time but identified as himself as AKA/SHAMUS FLYNN. He said that he did not know how old he was or his SSN. HAGGARD said he did not know his DOB but he was born in 1985. The name that HAGGARD gave was run in the computer. The physical description given for FLYNN did not match HAGGARD.</p> <p>HAGGARD was transported to Lakewood ER for treatment. He was accompanied by Ptl Krems. In the squad HAGGARD gave Ptl Krems another name and DOB. This time he identified himself as AKA/DAVID J LEE with a DOB of 12/7/84. This was run in the computer but the information was not matching up to what HAGGARD had provided us.</p> <p>HAGGARD finally positively identified himself to us at the ER. In running HAGGARD he has multiple warrants for his arrest out of Lakewood Muni Court. He also has a suspended license. HAGGARD said that he lied to conceal the facts listed above.</p> <p>HAGGARD was not issued a citation for False Information at this time. A summons request was submitted and forwarded to the Law Dept for review.</p>
