Topic Original Report

M.O.: By cutting the screen to a window and opening window to gain access to the business.

Lt WARNER Sir,


On 10/29/08, at 0255 Hrs, cars were detailed to WOBBLEFOOT LTD, 1662 Mars, on a center motion alarm.

Upon my arrival, I found the screen to a window on the North side of the building cut and the window open. The window to the West of the open window had also been cut, but no entry was gained. Other officers arrived on scene. Officer CANTLIN and I entered the business and found no one was inside. In checking the business, it was found that there were 2 fish sculptures on the window sill that had been damaged when the suspect entered the window. There was also a sea turtle sculpture that had been knocked off a table opposite the point of entry and damaged. Nothing appeared to be missing.

Dispatch contacted VIC/TUBAL COGAR, who is the owner of WOBBLEFOOT LTD. COGAR responded and checked the business and advised he did not notice anything missing, but he was not sure. COGAR advised he will have one of his assistants check their inventory at a later time and contact LPD if there was anything missing. COGAR advised that he believed the window, where entry was made, was locked, but there was no damage to the lock. Inv PICKENS arrived to process the scene, but he found nothing of evidentiary value.

In checking the point of entry, it is located along the North side of the building, along the driveway. It could be seen from 1650, 1657, 1661 Mars, but due to the hour I did not attempt to speak to anyone at those residences.

COGAR advised he does not have any suspects, but would desire prosecution if any are developed. COGAR was advised of the low solvability.
