

<p>M.O. By forcing open locked rear door and taking a laptop and stereo equipment.</p> <p>On 10-31-08, at 1751 Hrs., I was detailed to 2114 Wascana on report of a burglary. Upon arrival I spoke with VIC/MICHAEL STAHL who stated the following.</p> <p>STAHL stated on todays date, at 0900 Hrs., he left for work. STAHL stated when he left for work he locked the front and rear doors to his upstairs apartment. The downstairs rear door is always left unlocked. On todays date, at 1745 Hrs., STAHL came home and found that the rear door to his apartment had been forced open. STAHL entered his apartment and found that his laptop computer and stereo had been stolen. STAHL then called L.P.D..</p> <p>The stereo is also a DVD player and it was taken from on top of the TV in the living room. The sub woofer was taken from a mantel next to the TV. Two speakers were next to the TV and the second set of speakers were next to the couch. All cords were taken with the stereo equipment. The laptop was taken from STAHLs' office. The upstairs apartment has two floors. The office is connected by a set of stairs in the dining room. Nothing else was taken or disturbed inside the apartment.</p> <p>The back door to STAHLs' apartment was locked by a dead bolt. It appears the dead bolt was defeated by body force. No marks were observed on the door. The wooden door was split in several places. The front door was still locked. STAHL stated he lives by himself and has no suspects. Prosecution is desired. STAHL was advised of the low solvability.</p> <p>Inv. Allen was called to the scene. Photos were taken, no prints were found. The rear door to the residence is somewhat concealed by the garage. I canvassed the area and spoke with home owners at 2104 and 2116 Wascana. Both of these home owners were home during the time frame, but they did not see or hear anything unusual. I spoke with the downstairs tenant at 2112 Wascana and she stated she was at work during the time frame.</p> <p>On 10-31-08, at 1940 Hrs., STAHL contacted me and stated he is also missing his digital camera from his office. STAHL was advised this item would also be added to the report.</p>
