

<p>MO: By running from police officer after being told to stop.</p> <p>On 11/4/08, at 0132 Hrs., PO. GAMPFER and I were detailed to the area of Detroit and Bonnieview on a anonymous complaint of two black males allegedly selling drugs. On arrival to the area I observed two black males standing in front of Mccarthy's. I approached the males and one of the males took off running W/B on Detroit. PO. GAMPFER pulled her patrol car in front of the male and he ran back E/B. I pursued the male on foot and was able to take him into custody in the area of Detroit and Edwards.</p> <p>The male identified himself as ARA/STEVIE YOUNG. I advised YOUNG he was under arrest for Obstructing Official Business and secured him in the back of unit #206. YOUNG stated he ran because he recently moved to Lakewood and people told him that the Lakewood police are racist and would harass him.</p> <p>The male with YOUNG was identified as OIV/RICHARD GRAYSON GOLDEN. GRAYSON GOLDEN did not run and was advised by officers that we were investigating a complaint of possible drug activity. GRAYSON GOLDEN denied asking any one if they wanted to buy drugs.</p> <p>YOUNG was transported to LPD and booked in by CO. MCCARTHY and I for Obstructing Official Business. While at the booking window he was issued Criminal citation #M40920. YOUNG has no CCH.</p>
