Topic Supplemental Report

MO: By pushing the victim to the ground causing him physical injury.

On 11/7/08, at 2022 Hrs., officers were detailed to 11900 Detroit (Drug Mart) on a call from COM/MARIANNE FUGATE stating a man had been assaulted. On arrival, I spoke with VIC/CHARLES SKARUPA. SKARUPA stated that he had been "jumped" by three males. He said he was walking home S/B on Newman from Drug Mart when he was pushed from behind and knocked to the ground. SKARUPA stated the males got on top of him. He said he began to fight back and hit one of the males in the face with a bag containing a 22 OZ can of beer. The males ran S/B on Newman after he struck the male. SKARUPA stated he did not get a good look at the males. He said two of the males were white, around 18 to 20 years old. One was wearing a black shirt and the other a red shirt. He said he couldn't describe the third male at all.

SKARUPA had a small scrape on his right elbow. He advised the scrape was a result of the incident. SKARUPA had no other visible injuries. At the time of the alleged assault, SKARUPA was carrying two plastic grocery bags. One contained the can of beer and two packs of cigarettes. The other bag contained a gallon of milk that SKARUPA said broke open when he was assaulted. SKARUPA stated the males did not take any thing nor did they say what they wanted. He said the incident lasted only about fifteen seconds. It should be noted that I could detect a odor of an alcoholic beverage coming from his person. I asked him why he didn't walk home to call the police, considering he was just as close to home. He said he wanted to see if Drug Mart would replace his milk.

SKARUPA stated he did not desire medical attention. He said he would prosecute if the suspects were located. He provided a written statement. INV. DEUCHER took photos of SKARUPA'S elbow.
