Topic Original Report

M.O.-By punching victim repeatedly in the face, causing injury.

On 11-7-08 at approx. 2111 hours, Cars were detailed to Lakewood Hospital on the report of a male having been assaulted. Upon arrival I spoke with VIC-GOSNELL, who stated the following: He has been at the hospital all day with his sister, OIV-MILLER, who is in labor. At approx. 2050 hours he went outside and walked to his auto, which was parked in front of 1543 Belle. As he approached his auto, he saw two males standing next to the car. When GOSNELL got to the auto, they asked him "are you Mark?". GOSNELL advised that he was, and the two males proceeded to punch him and knock him on the ground. GOSNELL could only tell me that they were white males and gave the listed description. GOSNELL stumbled back to the hospital where they called the Police. GOSNELL has no idea who the males were nor which way they fled the area.

GOSNELL went on to tell us that his sister is having problems with her ex-boyfriend and baby's father, OIV-FEDROWIZ. There is a restraining order on file against FEDROWIZ with MILLER being the protected party. GOSNELL advised that FEDROWIZ'S cousin did show up at the hospital earlier wanting to see MILLER, but he was turned away. GOSNELL had no information on the cousin. Due to the fact that MILLER has been having problems with FEDROWIZ, he feels that the assault may be in retaliation of the break up between MILLER and FEDROWIZ. GOSNELL stated that he did not see FEDROWIZ in the area, and he does not recognize the two white male suspects as family or acquaintances of FEDROWIZ'S.

GOSNELL'S injuries on his face were photographed by Inv. Deucher. GOSNELL had some scratches and abrasions to his face. GOSNELL also had two swollen bumps, one on each side of his face from the assault. GOSNELL desires prosecution if suspects are developed in this matter. GOSNELL did not desire any medical attention.
