Topic Original Report

MO: By entering the home of another, by unknown means, and taking 3 watches without owner's knowledge or permission.

Sgt Gannon Sir,

On 11-08-08, at 1832HRS., I was detailed to 1137 Cranford for report of a burglary. When I arrived, I spoke with VIC/WILLIAM FREUND, who said three watches were taken from his bedroom. He said he was out of town since 11-02-08, and returned home today. He said he picked up his dog from OIV/COLON GOODWIN, who was dog sitting for him. GOODWIN has a key to the house and came daily to feed the cats. GOODWIN told FREUND that when he came to feed the cats on 11-07-08 the back door was unlocked. GOODWIN did not see anything missing so he fed the cats and left, and locked the door.

FREUND said he has a cleaning lady, OIV/MARY BODNAR, who also has a key. BODNAR came on 11-07-08 to do her usual cleaning. FREUND said BODNAR had told him that when she came to clean, the garage door was wide open. She said nothing seemed to be missing so she just closed the door. FREUND said he looked in the garage and nothing was missing from the garage. He said the garage door opener was off track, and he replaced it. He said that happens if you force the garage door open. There were no signs of forced entry on the garage door or the back door to the house.

FREUND said after he received the news of the back door and garage door being open, he looked around the house and did not notice anything missing. He said he then went up to his bedroom to change clothes and put his watch on the shelf near his bed and saw his other three watches were gone. He said he saw all three of the listed watches on the shelf by his bed when he left on 11-02-08, because he thought about which of the four watches he would want to wear while he was out of town. FREUND said he does not suspect BODNAR or GOODWIN. He said he knows both through church.

FREUND said the watches are insured through his homeowners insurance with Travelers insurance. He said he would call them about the incident. He had a serial number for the Breitling watch, and model numbers for the two Seiko watches. The two Seiko watches were the same model. All three watches were silver and gold in color. FREUND was advised of solvability and stated he wished prosecution.

Inv Deucher arrived to process the scene, nothing of value was found. Dispatcher Sykora entered the Breitling watch into leads.
