Topic Original Report

MO1/ By having a silver metal pipe on his person, with burnt marijuana residue in it.
MO2/ By being voluntarily intoxicated, with a strong odor of an alcoholic beverage on his breath, glassy bloodshot eyes, slurred speech, and posed a risk of harm to himself or others.

LT. WARNER SIR,

On 11-8-08, at 0349 hours, officers were detailed to 14718 Madison, CPY/ BP, on a report of an intoxicated male yelling inside of the business. The complainant, COM/ JODI LAHODNY, advised she was a cashier at BP. Upon arrival a customer outside of the store pointed to a male across the street in front of 14625 Madison, and stated he was the male who was causing the problems inside the BP. Officers then responded to the bus stop in front of 14625 Madison where the male was now standing, and identified the male as ARA/ JOSHUA CAMPBELL.

In speaking with CAMPBELL he said he had an argument with his friend while he was at BP. CAMPBELL had a strong odor of an alcoholic beverage on his breath, glassy bloodshot eyes, and slurred speech. CAMPBELL stated he had a warrant with this department because he did not show up for a court date. In running CAMPBELL he was found to have a warrant with this department for C of C, with his original charges being, DCI and Noise Disturbance. Dispatch advised the warrant was good. CAMPBELL was handcuffed and secured in the rear of my car #206.

In searching CAMPBELL incident to arrest, I located the indexed silver metal pipe with burnt marijuana residue in it, in CAMPBELL'S right front pants pocket. I confiscated the pipe, tagged it as evidence, and later placed it in the LPD Property Room drug chute.

CAMPBELL was transported by me to the LPD Jail and booked in by CO DANIEL MCCARTHY and I for the C of C warrant, Drug Paraphernalia, and DCI. CAMPBELL was issued misdemeanor citation number #M41333 for Drug Paraphernalia, and #M41334 for DCI. CAMPBELL was placed in the cell block to be held for bond on the C of C warrant.
