N A R R A T I V E 1	Topic	Original Report
M.O.: By remaining on the property of 16918 Detroit, McCarthy's Ale House, after being told to leave by Officers several times.		
On 11/8/08, at 0210 Hrs, Officers responded to McCarthy's, 16918 Detroit, regarding that was punched in the mouth. When I arrived on scene I spoke to SUB/MICHAEL BAJOREK and learned the following:		
BAJOREK stated he was punched in the face by a black male wearing a Yankees jersey. BAJOREK had a cut on his upper lip. BAJOREK did not elaborate on what took place before he was struck, but yelled how everyone watched and did not do anything about it. While Officer Misch and I spoke further with BAJOREK, Sgt. Eschweiler, Officer Schad and Officer Minter attempted to locate the other male inside McCarthy's.		
While we attempted to gather more information from BAJOREK, he refused to elaborate on what happened, but continued to accuse us of not doing our jobs. When BAJOREK was asked for his personal information, he refused to give it and told us we were harassing him and asked for my social security number. At this time, the security officer at McCarthy's indicated BAJOREK was no longer allowed to remain on the premises, and that prosecution would be desired. Due to BAJOREK being uncooperative, BAJOREK was told to leave by Officers several times. BAJOREK refused. He was then told he would be arrested for trespassing if he remained on the property. BAJOREK continued to remain on the property and told Officers he wanted to be arrested.		
BAJOREK was placed under arrest and secured in vehicle #214. BAJOREK was issued citation
