<p>LT Sprague, Sir,</p> <p>On patrol in the area of Northland/Hilliard on 11/08/2008 at 1605hrs. A female motorist in a black SUV flagged me down on Northland and asked: "Are you looking for a black guy going up and down people's driveways? He's over on Woodward right now!" I advised the motorist that I was simply on patrol and would look in to the matter, at which point she drove away. I was unable to obtain the female's information prior to her departure. I advised dispatch that I would be checking Woodward for the male.</p> <p>INV WALLING and PTL PIETCH arrived to help search the area. INV WALLING observed a black male, later identified as ARA/ARCHIE JAMES, JR., walking from the rear of 2115 Woodward towards the sidewalk with the listed red gas can in his hand. JAMES stated that the gas can belonged to him. JAMES stated that he was "cutting through yards" in order to reach "his boy's house." JAMES did not know whose yard he was in or had cut through. JAMES stated that he ran out of gas at the 7-11 store at Olive/Hilliard and was going to his "boy's house" in order to retrieve gasoline. JAMES could not tell officers where "his boy" lives or what "his boy's" name is. Considering that JAMES already had a 1/2</p>

full gas can on his person, JAMES' story was suspicious.

I spoke with the resident at 2115 Woodward, VIC/GARY HROVAT. HROVAT advised that he had two 1.25 GAL gas cans in his garage: 1 red empty can marked "snow thrower" and one red 1/2 full can that is not marked. HROVAT stated that he did not shut the garage door the last time he exited it. HROVAT went with me to the garage and advised that the unmarked can was missing. The two cans had been next to each other on a shelf in the back of the garage. HROVAT does not recall the last time he used the unmarked can, but advised that he has used it within "the last week or so." HROVAT identified the can we recovered from JAMES as his missing item.

JAMES was placed under arrest for Petty Theft and Criminal Trespassing and secured in unit #203. JAMES was transported to LPD and booked by CO GONZALEZ and this officer. JAMES was issued citation #M40963 for Petty Theft and M40964 for Criminal Trespassing.

JAMES' listed 1996 GMC Jimmy, OH/LIC R443578, was towed from the 7-11 parking lot by Kufner's.

JAMES' CCH includes Burglary, Obstructing Official Business, Criminal Damaging, and Assault.
