

	<p>On 11-10-08, at 1927 Hrs., (COM) SHERRI PAPPAS called police to her rental property at 1447 Graber Dr. to report that her former tenants damaged the property. I responded to the scene and spoke with PAPPAS who advised the following:</p>
	<p>PAPPAS rented the property to (SUB) ALAN RAUSCHER and (SUB) JOYCE YOUNG. They moved in on 5-10-08 with their four children.</p>
	<p>Today, PAPPAS received a call from RAUSCHER who told her they could not pay the rent and that they already moved out. PAPPAS did not know where they moved to.</p>
	<p>PAPPAS went to the home and found holes in the drywall, cracked tiles, and stained carpeting. Some of the walls had also been drawn on with a marker or crayon.</p> <p>PAPPAS had not been to the house since 5-10-08. She was advised this was a civil matter between her and her tenants.</p> <p>PAPPAS requested a report to document the incident. I took several photographs of the damaged walls at her request. PAPPAS took her own photographs as well.</p>
