Topic Original Report

M.O.; By remaining on the playground equipment after being told several times to get off of it;

On 11/13/08 at approx. 1706hrs. I was at Madison Park with Lt. JOYCE who was working at the Madison Library. We were approached by several adults who were complaining of the older juveniles being on the equipment that was meant for the younger children. They also said these same juveniles are using foul language and being disrespectful when they try to talk with them.

We talked with several juveniles when we went to the S side of the new park where there were approx. ten juveniles on a longer swaying/rocking ride. We advised the older juveniles that the equipment was meant for the younger juveniles 12 and under. Most were at least 14-15 or older. All understood and got off except one female, [REDACTED]. [REDACTED] was asked several times to get off as she was too big for the equipment. [REDACTED] refused and started arguing that the park was for everyone and was not going to get off. She was asked a few more times to get off and she refused.

[REDACTED] was advised she was under arrest for Trespassing and cuffed. Ptl. ROBINSON arrived and transported [REDACTED] to the station.

[REDACTED] mother was called to respond to the station for her daughter.
