

Topic Original Report

M.O. #1 Knowingly being in possession of a glass pipe with burnt marijuana residue

M.O. #2 Having an open 16 oz Sparks Plus, and a 40 oz Bud Light bottle, cold to the touch, and in plain view in her vehicle.

On 11/14/08, at 2251 hours, INV FIORILLI and I were patrolling the area of Westwood/Detroit. We checked the lot behind BAR 2, 15625 Detroit. We observed a female sitting in the indexed 2002, Chevy, Monte Carlo, LIC/ENA7766. The vehicle was backed into a parking space in the center row of the parking lot, approx 6 spaces east of Westwood.

We approached the vehicle, to speak with ARA/BRENNA L. METTLER. She advised that she was waiting to go into BAR 2. While speaking with METTLER, INV FIORILLI observed an orange and green glass pipe, commonly used to smoke marijuana, in plain view, on the center console of the vehicle.

I observed a 40 oz bottle of Bud Light laying on the floor board, in plain view behind the passenger's seat. The bottle appeared to be open. INV FIORILLI observed a 16 oz can of Sparks Plus partially exposed underneath the driver's seat. METTLER was told to exit the vehicle.

The seal on the Bud Light bottle was broken, and about 1/4 was gone. The bottle was still cold to the touch. The Sparks Plus can (7.0 alcohol by volume) was open, partially full, and also cold to the touch. The pipe, and alcohol were removed from the vehicle.

She stated the marijuana pipe belonged to her. In speaking with her, she advised "I don't see what the big problem is." The pipe contained burnt residue, that field tested positive for marijuana.

Regarding the alcohol in the vehicle, METTLER believed she could have the open bottle of alcohol in her vehicle, as long as the cap was on the bottle.

METTLER was issued citations #M40621 for Open Container, and #M40622 for Drug Paraphernalia. The alcohol was disposed of. We confiscated, tagged, and secured the marijuana pipe in the property room.
