<b>N A R R A T I V E  1</b>	<b>Topic</b> Original Report	<p>MO - By being in possession of the listed glass pipe containing burnt marijuana residue.</p> <p>On 11-14-08, at 1850 Hrs., an anonymous call was made to the police about possible drug use going on at 2006 Waterbury Ave #8. P.O. WINTRICK and I responded to the scene to investigate the complaint.</p> <p>I knocked on the door to apartment #8 and (ARA) ANTHONY WEST answered. When he opened the door, I could immediately smell a strong odor of burnt marijuana coming from inside the apartment.</p> <p>At first WEST denied using marijuana, but after realizing how strong the odor was, he admitted to smoking some prior to our arrival.</p> <p>WEST said the marijuana was all gone and let us in the apartment. In plain view on the bathroom floor, I observed the listed glass pipe. The pipe had burnt marijuana residue in it.</p> <p>The pipe was taken as evidence. It was tagged and placed down the drug chute in the property room. WEST was issued citation #M41930 for Drug Paraphernalia.</p> <p>Nothing else illegal was found in the apartment. WEST was released on the citation.</p>
